

## EXPLANATORY MEMORANDUM TO

### THE LONDON BOROUGH OF EALING (ELECTORAL CHANGES) ORDER 2020

2020 No. 65

#### 1. Introduction

- 1.1 This explanatory memorandum has been prepared by the Local Government Boundary Commission for England and is laid before Parliament by Command of Her Majesty.

#### 2. Purpose of the instrument

- 2.1 The Order provides for new wards and number of councillors for the London Borough of Ealing Council at the elections in 2022 and thereafter.

#### 3. Matters of special interest to Parliament

##### *Matters relevant to Standing Orders Nos. 83P and 83T of the Standing Orders of the House of Commons relating to Public Business (English Votes for English Laws)*

- 3.2 As the instrument is subject to negative resolution procedure there are no matters relevant to Standing Orders Nos. 83P and 83T of the Standing Orders of the House of Commons relating to Public Business at this stage.

#### 4. Extent and Territorial Application

- 4.1 The territorial extent of this instrument is England and Wales.  
4.2 The territorial application of this instrument is England.

#### 5. European Convention on Human Rights

- 5.1 As the instrument is subject to negative resolution procedure and does not amend primary legislation, no statement is required.

#### 6. Legislative Context

- 6.1 The Commission has power under section 59 of the Local Democracy, Economic Development and Construction Act 2009 (the 2009 Act) to make an order giving effect to recommendations contained in a report, prepared under section 58(4) of the 2009 Act, after conducting an electoral review under section 56(1) of that Act. This instrument is being made to give effect to the Commission's recommendations for new electoral arrangements set out in its report prepared following an electoral review of the London Borough of Ealing Council.

#### 7. Policy background

##### *What is being done and why?*

- 7.1 The purpose of an electoral review is to decide on the appropriate electoral arrangements including the number of councillors and the names, number and

boundaries of wards or divisions for a specific local authority. The Commission began the electoral review of Ealing in August 2018. The Commission decided to conduct the review because the last review of Ealing was completed in 1999. The Commission is required in legislation to conduct a review of the electoral arrangements of every council in England periodically.

- 7.2 An electoral review aims to ensure that the number of electors represented by each county or district councillor is as close to equal as possible, but the recommendations must also have regard to community identities and interests and the need for effective and convenient local government. To achieve these aims, the Commission tries to ensure that the number of electors per councillor in every division or ward is as close as possible to the average for the authority, but is happy to show flexibility in moving away from the average based on the evidence provided during the consultation stages of the review. Following a four-stage review process the Commission published its ‘New electoral arrangements for Ealing Council – Final Recommendations’<sup>1</sup> on 2 July 2019.
- 7.3 The Order provides for changes to the electoral arrangements for Ealing at its next elections in 2022 as recommended by the Commission. The existing wards of the council will be replaced by 24 new ones. Twenty two wards will each return three councillors, and two wards will return two councillors.
- 7.4 Under section 56 of the 2009 Act, whenever the Commission recommends changes to the electoral arrangements for a borough, district or county council it must also recommend whether, in consequence of those changes, any changes should be made to the electoral arrangements for any parish council that is within the authority. Among other things, under Schedule 2 to that Act, recommendations must ensure that no parish ward is split between new wards, and under section 56 of that Act, recommendations must be made regarding the number of parish councillors for each parish ward.
- 7.5 In the case of Ealing, this does not apply as the authority does not contain any parish councils.

## **8. European Union (Withdrawal) Act/Withdrawal of the United Kingdom from the European Union**

- 8.1 This instrument does not relate to withdrawal from the European Union.

## **9. Consolidation**

- 9.1 This Instrument does not amend or revoke any legislation.

## **10. Consultation outcome**

- 10.1 The Order gives effect to recommendations that were consulted on during the review of electoral arrangements from August 2018 to March 2019. During the course of the review, the Commission received approximately 225 representations. The consultations involved the Council, local MPs, local residents and other interested parties. There was an initial ten-week consultation, during which the Commission asked for proposals on the most appropriate number of councillors and ward

boundaries for Ealing. The Commission considered that a council size of 69 would ensure effective and convenient local government for the authority. Having considered the submissions received, the Commission published its 'Draft recommendations - New electoral arrangements for Ealing Council'<sup>2</sup> on 5 February 2019. Having carefully considered the evidence received during consultation, the Commission decided that 70 councillors, rather than 69, would ensure better electoral equality across the area. Following a ten-week consultation on the draft recommendations, the Commission considered the further evidence received and published its final recommendations.

- 10.2 In response to the consultation on the draft recommendations, the Commission modified its recommendations for Ealing Broadway, North Hanwell and Pitshanger wards because of the community evidence provided by local residents in this area. It also recommended that Acton Green ward be renamed Southfield and South Ealing ward be renamed Northfield, based on evidence received from local residents.
- 10.3 The Commission confirmed its draft recommendations for the remainder of Ealing as final.
- 10.4 A detailed analysis of the outcome of the consultation is set out in the report 'Final recommendations - New electoral arrangements for Ealing Council' which is available at <http://s3-eu-west-2.amazonaws.com/lgbce/Reviews/Greater%20London/Ealing/Final%20recs/Ealing%20report%20web.pdf>.

## **11. Guidance**

- 11.1 The Commission does not intend to issue any guidance alongside this instrument. This is not considered necessary as the Order is self-explanatory and gives effect to recommendations following consultation with interested parties as to the changes to electoral arrangements.

## **12. Impact**

- 12.1 There is no impact on business, charities or voluntary bodies.
- 12.2 The impact on the public sector will be limited to the area for which the Order makes provision. The one-off cost of producing the map referred to by the instrument is to be funded by the Commission. The one-off cost of amending the electoral register to reflect the new wards is to be funded by Ealing Council.
- 12.3 An Impact Assessment has not been prepared for this instrument.

## **13. Regulating small business**

- 13.1 The legislation does not apply to activities that are undertaken by small businesses.

## **14. Monitoring & review**

- 14.1 The Commission will have no role in monitoring the Council's implementation of the London Borough of Ealing (Electoral Changes) Order 2020. The Commission is not required to undertake such monitoring; that is a matter for the relevant officers of the

Council. The Order will be reviewed insofar as the Commission continually monitors local authorities in England to identify any that meet its criteria for electoral reviews.
