#### Critical suppliers to government

## Interpretation

1. In this Schedule—

"government" has the same meaning as "contracting authorities" in regulation 2 of the Public Contracts Regulations 2015(1);

"relevant public contract" means a contract for pecuniary interest between one or more persons and government, where the contract has as its object the execution of works, the supply of products or the provision of services.

**2.** A qualifying entity being a party to a relevant public contract where the contract contains one or more of the features set out in paragraph 2.

  - (c) a requirement for employees of the qualifying entity to be vetted at or above 'Security Check' level as described in guidance titled "National security: vetting clearance levels" published on 12 February 2020(4) by the United Kingdom Security Vetting.
