The Health Protection (Coronavirus, International Travel and Operator Liability) (England) (Amendment) (No. 20) Regulations 2021

The Secretary of State makes the following Regulations in exercise of the powers conferred by sections 45B, 45F(2) and 45P(2) of the Public Health (Control of Disease) Act $1984(\mathbf{a})$.

Citation, commencement, extent, application and interpretation

1.—(1) These Regulations may be cited as the Health Protection (Coronavirus, International Travel and Operator Liability) (England) (Amendment) (No. 20) Regulations 2021.

(2) These Regulations come into force at 4.00 a.m. on 28th November 2021.

(3) These Regulations extend to England and Wales and apply in relation to England only.

(4) In these Regulations, "the principal Regulations" means the Health Protection (Coronavirus, International Travel and Operator Liability) (England) Regulations 2021(**b**).

Amendments to the principal Regulations

2.—(1) The principal Regulations are amended as follows.

(2) In Schedule 3 (Category 3 countries and territories), in the appropriate place in alphabetical order, insert—

"Angola"

"Malawi"

"Mozambique"

"Zambia".

(3) In paragraph 4 of Schedule 13 (Prohibition on the arrival of aircraft into England), in the appropriate place in alphabetical order, insert—

"Angola"

"Malawi"

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Health Protection (Coronavirus, International Travel and Operator Liability) (England) Regulations 2021 (S.I. 2021/582). They add four countries to the list of Category 3 countries and territories in Schedule 3, and amend Schedule 13 to prevent aircraft from those countries arriving in England except in limited circumstances.
