## PERSONAL ALLOWANCES

1. The weekly amounts specified in column (2) below in respect of each person or couple specified in column (1) shall be the weekly amounts specified for the purposes of regulations 17(1) and 18(1) (applicable amounts and polygamous marriages)—

(3)(3) Couple— (a) where both members are aged less than 18 and— (i) at least one of them is treated as responsible for a child; or (ii) had they not been members of a couple, each would have qualified for income support under regulation 4ZA or income-related employment and support allowance; or (iii) the claimant's partner satisfies the requirements of section 3(1)(f)(iii) of the Jobseekers Act 1995 (prescribed circumstances for persons aged 16 but less than 18); or	(3) (a) £89.45;
