The Guaranteed Minimum Pensions Increase Order 2021

Made - - - - *1st March 2021*

Coming into force - - *6th April 2021*

The Secretary of State for Work and Pensions has reviewed the general level of prices in Great Britain for the period of 12 months commencing on 1st October 2019 as required by section 109(1) of the Pension Schemes Act 1993(a), and it appears to the Secretary of State that the general level of prices was greater by 0.5 per cent. at the end of that period than it was at the beginning of that period.

A draft of this Order was laid before Parliament in accordance with section 109(2) of that Act(b) and approved by a resolution of each House.

Accordingly, the Secretary of State makes this Order in exercise of the power conferred by section 109(4) of that Act.

Citation and commencement

1. This Order may be cited as the Guaranteed Minimum Pensions Increase Order 2021 and comes into force on 6th April 2021.

Increase of guaranteed minimum pensions

2. For the purposes of section 109(2) and (3) of the Pension Schemes Act 1993, the percentage by which there is to be an increase of the rate of that part of guaranteed minimum pensions which is attributable to earnings factors for the tax years in the relevant period(c) is 0.5 per cent.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order specifies 0.5 per cent. as the percentage by which that part of guaranteed minimum pensions attributable to earnings factors for the tax years 1988-89 to 1996-97 and payable by contracted-out, defined benefit occupational pension schemes is to be increased. Under section 109(3) of the Pension Schemes Act 1993 (c. 48) the percentage to be specified is the actual percentage increase in the general level of prices in the period under review or 3 per cent., whichever is less.

A full impact assessment has not been produced for this instrument as no, or no significant, impact on the private, voluntary or public sector is foreseen.

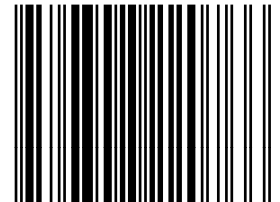
