The Approved Country Lists (Animals and Animal Products) (Amendment) Regulations 2021

Made----26th February 2021Laid before Parliament2nd March 2021Coming into force-28th March 2021

The Secretary of State, in exercise of the powers conferred by regulations 6 to 9, 11 and 12 of the Trade in Animals and Animal Products (Legislative Functions) and Veterinary Surgeons (Amendment) (EU Exit) Regulations 2019(a), makes the following Regulations.

In accordance with the requirements of the regulations mentioned above, the Secretary of State has obtained the consent of the appropriate authority(**b**).

#### Citation and commencement

- **1.**—(1) These Regulations may be cited as the Approved Country Lists (Animals and Animal Products) (Amendment) Regulations 2021.
  - (2) They come into force on 28th March 2021.

These Regulations are made in exercise of powers conferred by the Trade in Animals and Animal Products (Legislative Functions) and Veterinary Surgeons (Amendment) (EU Exit) Regulations 2019 (S.I. 2019/1225), in particular, regulations 6 to 9, 11 and 12.

They amend entries in the approved lists contained in retained direct EU legislation for imports of certain types of products, including food and animal products. The amendments are principally to entries relating to Iceland.
