The A303 Sparkford to Ilchester Dualling Development Consent (Correction) Order 2021

The A303 Sparkford to Ilchester Dualling Development Consent Order 2021 ("the Order")(1), which granted development consent within the meaning of the Planning Act 2008 ("the Act")(2), contains correctable errors as defined in paragraph 1(3) of Schedule 4 to the Act.

The Secretary of State, in exercise of the powers conferred by section 119 of, and paragraph 1(4) and (8) of Schedule 4 to, the Act, makes the following Order:

#### Citation and commencement

**1.** This Order may be cited as the A303 Sparkford to Ilchester Dualling Development Consent (Correction) Order 2021 and comes into force on 21st May 2021.
