COUNTRYSIDE, ENGLAND

The Access to the Countryside (Coastal Margin) (East Head to Shoreham) Order 2023

Made - - - - *17th October 2023*

Coming into force - - *18th October 2023*

The Secretary of State makes this Order in exercise of the powers conferred by section 3A(10) of the Countryside and Rights of Way Act 2000(1).

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Access to the Countryside (Coastal Margin) (East Head to Shoreham) Order 2023 and comes into force on the day after the day on which it is made.

(2) In this Order—

“the Act” means the National Parks and Access to the Countryside Act 1949(2);

“the relevant approval” means the approval by the Secretary of State(3) under section 52(1) of the Act(4) of the relevant report on 18th March 2021;

“the relevant report” means the report entitled “Coastal Access (East Head to Shoreham)” submitted by Natural England to the Secretary of State under sections 51 and 55A of the Act(5) on 27th September 2017(6).

(3) The functions of the Secretary of State under sections 51 and 52 of the National Parks and Access to the Countryside Act 1949 (c. 97) were originally vested in the Minister of Town and Country Planning in relation to England and Wales (see section 114(1) of that Act). The Minister of Town and Country Planning was renamed the Minister of Local Government and Planning by S.I. 1951/142, and was further renamed the Minister of Housing and Local Government by S.I. 1951/1900. S.I. 1965/143 transferred (so far as relevant) the functions of the Minister of Housing and Local Government to the Minister of Land and Natural Resources. The Ministry of Land and Natural Resources was dissolved by S.I. 1967/156 and the functions of that Minister (so far as relevant) were transferred to the Minister of Housing and Local Government. The Ministry of Housing and Local Government was dissolved and the functions of that Minister were transferred to the Secretary of State by S.I. 1970/1681.

2. In relation to land which is coastal margin as a result of the relevant approval, the day appointed as the day on which the access preparation period⁽⁷⁾ ends is 18th October 2023.
