The Secretary of State makes these Regulations in exercise of the powers conferred by section 87(1) of the Nationality and Borders Act 2022(a).

#### Citation and extent

- **1.**—(1) These Regulations may be cited as the Nationality and Borders Act 2022 (Commencement No. 8) Regulations 2023.
  - (2) These Regulations extend to England and Wales, Scotland and Northern Ireland.

## Provision coming into force on 20th November 2023

**2.** Section 46(8) of the Nationality and Borders Act 2022 (removals: notice requirements) comes into force on 20th November 2023.

## **EXPLANATORY NOTE**

These Regulations bring into force on 20th November 2023 section 46(8) of the Nationality and Borders Act 2022 (c. 36). Section 46(8) relates to the power of the First-tier Tribunal to grant immigration bail without the consent of the Secretary of State.
