The Little Crow Solar Park (Correction) Order 2023

The Little Crow Solar Park Order 2022(1) ("the Order"), which granted development consent within the meaning of the Planning Act 2008(2) ("the Act") contains correctable errors within the meaning of paragraph 1 of Schedule 4 to the Act.

Citation and commencement

1. This Order may be cited as the Little Crow Solar Park (Correction) Order 2023 and comes into force on 10th March 2023.
