**The Air Navigation (Restriction of Flying) (Cleethorpes)
Regulations 2023**

Made - - - - *20th April 2023*

Coming into force - - *17th June 2023*

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the area specified in regulation 3(1) by reason of the intended holding there of flying displays associated with the North East Lincolnshire Armed Forces Weekend 2023.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Cleethorpes) Regulations 2023 and they come into force on 17th June 2023.

Interpretation

2. In regulation 3(1) the times referred to are Co-ordinated Universal Time(b).

Restricted airspace

3.—(1) Subject to paragraph (2), between 1130 hours and 1630 hours on 17th June 2023 and 18th June 2023 no aircraft is to fly below 3,000 feet above mean sea level within the area bounded by a circle having a radius of 2 nautical miles centred at 533330N 0000107W.

(2) Paragraph (1) does not apply to any aircraft operating with the permission of the North East Lincolnshire Armed Forces Weekend flying display director.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in the vicinity of Cleethorpes, Lincolnshire during flying displays associated with the North East Lincolnshire Armed Forces Weekend 2023 (national event) that are scheduled to take place there on 17th June 2023 and 18th June 2023.

Many aircraft will be involved in high energy manoeuvres during the displays and therefore the Civil Aviation Authority and the Department for Transport agree that flying should be restricted in the vicinity of the event for reasons of public safety.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).

In relation to the permission mentioned in regulation 3(2), the North East Lincolnshire Armed Forces Weekend flying display director may be contacted on telephone 07950 967282.

Full details of this Statutory Instrument will be promulgated by Aeronautical Information Circular (AIC) and Notice to Aviation (NOTAM).
