**The Air Navigation (Restriction of Flying) (Brighton)  
Regulations 2023**

*Made* - - - - *5th June 2023*

*Coming into force* - - *21st July 2023*

The Secretary of State has decided that it is necessary in the public interest to restrict the flying of unmanned aircraft in the area specified in regulation 3(1) by reason of the intended gathering of a large number of persons at a music festival which is due to take place there.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016<sup>(a)</sup>.

**Citation and commencement**

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Brighton) Regulations 2023 and they come into force on 21st July 2023.

**Interpretation**

2. In regulation 3(1) the times referred to are Co-ordinated Universal Time<sup>(b)</sup>.

**Restricted airspace**

3.—(1) Subject to paragraph (2), between 1100 hours and 2300 hours on each of the ten days commencing on 21st July 2023 and ending 30th July 2023 no unmanned aircraft is to fly below 500 feet above mean sea level within the area bounded by—

(a) a straight line joining successively the following points—

(i) 504911N 0000800W, and

(ii) 504904N 0000723W, and

(b) the clockwise arc of a circle having a radius of 0.21 nautical miles centred at 504904N 0000743W between 504904N 0000723W and 504911N 0000800W.

(2) Paragraph (1) does not apply to any unmanned aircraft flying in accordance with a permission issued by the event control team.

(b) Co-ordinated Universal Time (UTC) is one hour behind British Summer Time (BST).

### **EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations impose restrictions on the flying of unmanned aircraft in the vicinity of Brighton, East Sussex by reason of the large gathering of persons expected to attend a music festival which is due to be held there on 21st July 2023 to 30th July 2023 (inclusive).

The Civil Aviation Authority and the Department for Transport agree that the flying of unmanned aircraft should be restricted in the vicinity of the festival for reasons of public safety.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).
