# The Civil Enforcement of Moving Traffic Contraventions Designation Order 2023

### Designation of civil enforcement areas

#### Designation of civil enforcement areas for moving traffic contraventions

- 3. The Secretary of State designates each of the following areas as a civil enforcement area for moving traffic contraventions-
