**The Combined Authorities (Overview and Scrutiny Committees, Access to Information and Audit Committees) (Amendment) Regulations 2024**

**PART 3**

Amendment of other secondary legislation

**The Greater Manchester Combined Authority Order 2011**

**19.** In paragraph 3C of Schedule 1 (remuneration)(1) to the Greater Manchester Combined Authority Order 2011—

- (a) in sub-paragraph (1) for “(3)(a)” substitute “(3)”,
- (b) in sub-paragraph (2) after “council” insert “or a member of a constituent council who is appointed to an overview and scrutiny committee or a sub-committee of that committee, or to the audit committee of the GMCA”;
- (c) in sub-paragraph (3) for paragraph (b) substitute—
  - “(b) the GMCA may pay an allowance not exceeding the allowance recommended by the independent remuneration panel to elected members of constituent councils appointed to an overview and scrutiny committee, including to any sub-committee of that committee, or to the audit committee;”.

**The Barnsley, Doncaster, Rotherham and Sheffield Combined Authority Order 2014**

**20.** In Schedule 1 (constitution) to the Barnsley, Doncaster, Rotherham and Sheffield Combined Authority Order 2014(2)—

- (a) in paragraph 7—
  - (i) for “7A and 7B” substitute “7A, 7B and 7C”;
  - (ii) after “members” insert “or to members of a constituent council who are appointed to an overview and scrutiny committee or sub-committee, or to the audit committee of the Combined Authority”;
- (b) in paragraph 7B(1)—
  - (i) at the end of paragraph (a) omit “and”;
  - (ii) after paragraph (b) insert—
    - “(c) a member of a constituent council who is appointed to an overview and scrutiny committee or a sub-committee of that committee; and

- (d) a member of the Combined Authority or of a constituent council who is appointed to the audit committee”;
- (c) in paragraph 7C—
  - (i) in the opening words, for “to the Mayor or Deputy Mayor” substitute “in accordance with paragraph 7B(1)”;
  - (ii) in sub-paragraph (a), for “7A” substitute “7B”.

### **The West Yorkshire Combined Authority Order 2014**

**21.** In Schedule 1 (constitution) to the West Yorkshire Combined Authority Order 2014(3)—

- (a) in paragraph 7 (remuneration)—
  - (i) after “9” insert “, 9A”;
  - (ii) after “members” insert “or to members of a constituent council who are appointed to an overview and scrutiny committee or sub-committee, or to the audit committee, of the Combined Authority”;
- (b) after paragraph 9 insert—

“9A. The Combined Authority may pay an allowance to—

  - (a) a member of a constituent council who is appointed to an overview and scrutiny committee of the Combined Authority, or a sub-committee of that committee,
  - (b) a member of the Combined Authority or a member of a constituent council who is appointed to the audit committee of the Combined Authority,

in accordance with any recommendations made by its independent remuneration panel.”.

### **The Halton, Knowsley, Liverpool, St Helens, Sefton and Wirral Combined Authority Order 2014**

**22.** In Schedule 1, paragraph 7 (remuneration) to the Halton, Knowsley, Liverpool, St Helens, Sefton and Wirral Combined Authority Order 2014(4)—

- (a) for sub-paragraph (1) substitute—

“(1) Subject to sub-paragraph (3), no remuneration is to be payable by the Combined Authority to—

  - (a) its members, other than allowances for travel and subsistence paid in accordance with a scheme drawn up by the Combined Authority;
  - (b) members of a constituent council who are appointed to an overview and scrutiny committee or sub-committee, or to members of the Combined Authority or a constituent council who are appointed to the audit committee, of the Combined Authority.”;
- (b) in sub-paragraph (3)—
  - (i) in the opening words, after “Mayor” insert “or to a member of the Combined Authority or to a member of a constituent council referred to in sub-paragraph (1) (b)”;
  - (ii) in paragraph (a) for the words from “by one or more” to “2003” substitute “in accordance with article 16 of the Combined Authorities (Overview and Scrutiny Committees, Access to Information and Audit Committees) Order 2017”.

### **The Tees Valley Combined Authority Order 2016**

**23.** In Schedule 1, paragraph 7 (remuneration), to the Tees Valley Combined Authority Order 2016<sup>(5)</sup>—

- (a) in sub-paragraph (1)—
  - (i) for “paragraph (2)” substitute “sub-paragraphs (2) and (3)”;
  - (ii) after “members” insert “or to members of a constituent council who are appointed to an overview and scrutiny committee or sub-committee or to the audit committee of the Combined Authority”;
- (b) after sub-paragraph (2) insert—

“(3) The Combined Authority may pay an allowance to—

  - (a) a member of a constituent council who is appointed to an overview and scrutiny committee of the Combined Authority, or a sub-committee of that committee,
  - (b) a member of the Combined Authority or a member of a constituent council who is appointed to the audit committee of the Combined Authority,

in accordance with any recommendations made by its independent remuneration panel.”.

### **The West Midlands Combined Authority Order 2016**

**24.** In Schedule 1, paragraph 7 (remuneration), to the West Midlands Combined Authority Order 2016<sup>(6)</sup>—

- (a) in sub-paragraph (1)—
  - (i) for “paragraph (2)” substitute “sub-paragraphs (2) and (3)”;
  - (ii) after “members” insert “or to members of a constituent council who are appointed to an overview and scrutiny committee or sub-committee or to the audit committee of the Combined Authority”;
- (b) after sub-paragraph (2) insert—

“(3) The Combined Authority may pay an allowance to—

  - (a) a member of a constituent council who is appointed to an overview and scrutiny committee of the Combined Authority, or a sub-committee of that committee,
  - (b) a member of the Combined Authority or a member of a constituent council who is appointed to the audit committee of the Combined Authority,

in accordance with any recommendations made by its independent remuneration panel.”.

### **The West of England Combined Authority Order 2017**

**25.** In Schedule 1, paragraph 8 (remuneration) to the West of England Combined Authority Order 2017<sup>(7)</sup>—

- (a) in sub-paragraph (1)—
  - (i) for “sub-paragraph (2)” substitute “sub-paragraphs (2) and (3)”;
  - (ii) after “members” insert “or to members of a constituent council who are appointed to an overview and scrutiny committee or sub-committee or to the audit committee of the Combined Authority”;
- (b) after sub-paragraph (2) insert—

- “(3) The Combined Authority may pay an allowance to—
- (a) a member of a constituent council who is appointed to an overview and scrutiny committee of the Combined Authority, or a sub-committee of that committee,
  - (b) a member of the Combined Authority or a member of a constituent council who is appointed to the audit committee of the Combined Authority,
- in accordance with any recommendations made by its independent remuneration panel.”.

### **The Cambridge and Peterborough Combined Authority Order 2017**

**26.** In the Schedule to the Cambridge and Peterborough Combined Authority Order 2017(8), for paragraph 8 (remuneration) substitute—

“**8.**—(1) Save as provided for in sub-paragraphs (2) and (3), no remuneration is to be payable by the Combined Authority to its members or to members of a constituent council referred to in sub-paragraph (2)(b) and (c), other than allowances for travel and subsistence paid in accordance with a scheme drawn up by the Combined Authority.

- (2) The Combined Authority may pay an allowance to—
  - (a) the Mayor;
  - (b) a member of a constituent council who is appointed to an overview and scrutiny committee of the Combined Authority or to a sub-committee of that committee; or
  - (c) a member of the Combined Authority or to a member of a constituent council who is appointed to the audit committee of the Combined Authority.
- (3) The Combined Authority may only pay an allowance under sub-paragraph (2) if—
  - (a) the Combined Authority has considered a report published by an independent remuneration panel established in accordance with article 16 of the Combined Authorities (Overview and Scrutiny Committees, Access to Information and Audit Committees) Order 2017 which contains recommendations for such an allowance; and
  - (b) the allowance paid by the Combined Authority does not exceed the amount specified in the recommendation made by that panel.”.
