The National Grid (Yorkshire Green Energy Enablement Project) (Corrections) Order 2024

Made - - - - *11th June 2024*
Coming into force - - *12th June 2024*

The National Grid (Yorkshire Green Energy Enablement Project) Development Consent Order 2024 (“the 2024 Order”)(**1**), which granted development consent within the meaning of the Planning Act 2008 (“the Act”)(**2**), contained correctable errors within the meaning of the Act(**3**). Before the end of the relevant period, as defined in paragraph 1(6)(a) of Schedule 4 to the Act, the Secretary of State received a written request from the applicant(**4**) for the correction of errors in the 2024 Order.

The Secretary of State has informed the relevant local planning authorities for the area in which the land to which the 2024 Order relates is situated, that the request has been received in accordance with paragraph 1(7) of Schedule 4 to the Act.

The Secretary of State, in exercise of the powers conferred by section 119 of, and paragraphs 1(4) and (8) of Schedule 4 to, the Act, makes the following Order.

Citation and commencement

1. This Order may be cited as the National Grid (Yorkshire Green Energy Enablement Project) (Corrections) Order 2024 and comes into force on the day after the day on which it is made.
