The Social Security (Scotland) Act 2018 (Disability Assistance) (Consequential Amendments) Order 2024

Made - - - - 9th September 2024

Laid before Parliament 10th September 2024

Coming into force - 21st October 2024

The Secretary of State makes this Order in exercise of the powers conferred by sections 104, 112(1) and 113(2) and (3) of the Scotland Act 1998(a).

PART 1

Citation, commencement and extent

Citation, commencement and extent

- 1.—(1) This Order may be cited as the Social Security (Scotland) Act 2018 (Disability Assistance) (Consequential Amendments) Order 2024 and comes into force on 21st October 2024.
 - (2) Part 1 of this Order extends to England and Wales, Scotland and Northern Ireland.
 - (3) Part 2 of this Order extends to England and Wales only.
 - (4) Part 3 of this Order extends to England and Wales and Scotland.
 - (5) Part 4 of this Order extends to Northern Ireland only.

PART 2

England and Wales

Amendment of the Social Security (Invalid Care Allowance) Regulations 1976

EXPLANATORY NOTE

(This note is not part of the Order)

The Disability Assistance for Older People (Scotland) Regulations 2024 (S.S.I. 2024/166) introduce arrangements for the payment of disability assistance in the form of pension age disability payment. Pension age disability payment replaces attendance allowance in Scotland.

This instrument makes consequential amendments to social security legislation in England and Wales, Scotland and Northern Ireland, as the case may be, governing entitlement to certain benefits.

A full impact assessment has not been produced for this instrument as no, or no significant, impact on the private, voluntary or public sectors is foreseen.
