In exercise of the powers conferred on the Secretary of State by section 356(2)(a) and (b) and (4) of the Education Act 1996⁽¹⁾ and now vested in the National Assembly for Wales⁽²⁾, the National Assembly for Wales makes the following Order:

PROSPECTIVE

Citation, commencement, interpretation and application **E+W**

1.—(1) This Order may be cited as the Education (National Curriculum) (Attainment Targets and Programmes of Study in Music) (Wales) Order 2000 and shall come into force on 1st August 2000.

(2) In this Order—

“the Authority” (“*yr Awdurdod*”) means the Qualifications, Curriculum and Assessment Authority for Wales⁽³⁾;

“the Document” (“*y Ddogfen*”) means the document published by the Authority in 2000 entitled “Music in the National Curriculum”⁽⁴⁾;

“the National Assembly” (“*y Cynulliad Cenedlaethol*”) means the National Assembly for Wales.

(3) This Order applies only in relation to schools in Wales.

EXPLANATORY NOTE

The National Curriculum for Wales for Music will be revised from 1st August 2000. This Order gives legal effect to the new programmes of study, which set out what pupils should be taught, and attainment targets for them. Details of these are set out in a document called “Music in the National Curriculum” which is available from the Qualifications, Curriculum and Assessment Authority for Wales.

The Order replaces the Education (National Curriculum) (Attainment Targets and Programmes of Study in Music) (Wales) Order 1998.
