Mae'r Rheoliadau hyn yn peri diwygiadau pellach i Rheoliadau'r Gwasanaeth Iechyd Gwladol (Gwasanaethau Meddygol Cyffredinol) 1992 ("y prif Rheoliadau"), sy'n rheoleiddio'r telerau y mae Gwasanaethau Meddygol Cyffredinol yn cael eu darparu odanynt o dan Ddeddf y Gwasanaeth Iechyd Gwladol 1977.

These Regulations further amend the National Health Service (General Medical Services) Regulations 1992 ("the principal Regulations"), which regulate the terms on which General Medical Services are provided under the National Health Service Act 1977.

Mae Rheoliad 2 yn ychwanegu'r cyffur Finasteride 1mg (Propecia) at y rhestr yn Atodlen 10 i'r prif Rheoliadau sy'n rhestru cyffuriau a sylweddau eraill na ellir eu rhoi ar bresgripsiwn i'w cyflenwi yng nghwrs gwasanaethau fferyllol sy'n cael eu darparu o dan Ddeddf y Gwasanaeth Iechyd Gwladol 1977.

Regulation 2 adds the drug Finasteride 1mg (Propecia) to the list in Schedule 10 to the principal Regulations, which lists drugs and other substances that may not be prescribed for supply in the course of pharmaceutical services provided under the National Health Service Act 1977.

**Citation, commencement and application**

1.-(1) These Regulations may be cited as the National Health Service (General Medical Services) Amendment (No.3) (Wales) Regulations 2000 and shall come into force on 1st August 2000.

(2) These Regulations shall apply to Wales only.

**Amendment of the National Health Service  
(General Medical Services) Regulations 1992**

2. In Schedule 10 to the National Health Service (General Medical Services) Regulations 1992 (b), the following entries shall be inserted in such places in the
