Mae "iaith dramor fodern" yn un o bynciau sylfaen y Cwricwlwm Cenedlaethol yng Nghymru mewn perthynas â'r trydydd cyfnod allweddol. Mae'n ofynnol i'r ieithoedd hynny sydd i gyfrif fel ieithoedd modern at ddibenion y Cwricwlwm Cenedlaethol gael eu pennu mewn Gorchymyn a wneir gan y Cynulliad Cenedlaethol, neu, fel arall, caiff Gorchymyn o'r fath ddarparu bod unrhyw iaith dramor fodern yn iaith dramor fodern at y dibenion hynny.

Ieithoedd swyddogol y Gymuned Ewropeaidd yw'r ieithoedd a bennir gan y Gorchymyn ym mhob achos. Yn ychwanegol, yn achos ysgol lle cynigir cyfle i ddisgyblion y trydydd cyfnod allweddol astudio o leiaf un o ieithoedd swyddogol y Gymuned Ewropeaidd, mae'r Gorchymyn yn darparu bod "unrhyw" iaith dramor fodern yn iaith dramor fodern at ddibenion y Cwricwlwm Cenedlaethol. Yn hyn o beth, mae'n wahanol i Gorchymyn Addysg (Y Cwricwlwm Cenedlaethol) (Ieithoedd Tramor Modern) 1991, y mae'n ei ddisodli, yn yr ystyr mai dim ond yr ieithoedd tramor modern hynny a restrwyd ynddo a bennwyd gan y Gorchymyn cynharach tra bod y Gorchymyn presennol yn pennu unrhyw iaith dramor fodern.

A "modern foreign language" is a National Curriculum foundation subject in Wales in relation to the third key stage. Those languages which are to count as modern languages for the purposes of the National Curriculum are required to be specified in an Order made by the National Assembly, or, alternatively, such an Order may provide that any modern foreign language is a modern foreign language for such purposes.

The languages specified by the Order are, in all cases, the official languages of the European Community. In addition, in the case of a school at which third key stage pupils are offered the opportunity of studying at least one official language of the European Community, the Order provides that "any" modern foreign language is a modern foreign language for the purposes of the National Curriculum. In this respect, it differs from the Education (National Curriculum) (Modern Foreign Languages) Order 1991 which it replaces in that the earlier Order specified only those modern foreign languages listed in the Order whereas the present Order specifies any modern foreign language.

Drwy arfer y pwerau a roddwyd i Gynulliad Cenedlaethol Cymru gan adran 354(4) a (5) o Ddeddf Addysg 1996(a), mae Cynulliad Cenedlaethol Cymru yn gwneud y Gorchymyn canlynol:

In exercise of the powers conferred on the National Assembly for Wales by section 354(4) and (5) of the Education Act 1996(a), the National Assembly for Wales makes the following Order:

1.-(1) Enw'r Gorchymyn hwn yw Gorchymyn Addysg (Y Cwricwlwm Cenedlaethol) (Ieithoedd Tramor Modern) (Cymru) 2000 a daw i rym ar 1 Awst 2000.

1.-(1) This Order may be cited as the Education (National Curriculum) (Modern Foreign Languages) (Wales) Order 2000 and shall come into force on 1st August 2000.

references to official languages of the European Community are to languages specified as official languages of the institutions of the European Community by Article 1 of EEC Council Regulation No.1 of April 15 1958(b).

(3) Mae'r Gorchymyn hwn yn gymwys i Gymru.

(3) This Order applies to Wales.

2. Diddymir drwy hyn Orchymyn Addysg (Y Cwricwlwm Cenedlaethol) (Ieithoedd Tramor Modern) 1991(c) a Gorchymyn Addysg (Y Cwricwlwm Cenedlaethol) (Ieithoedd Tramor Modern) (Diwygio) 1994(d) mewn perthynas â Chymru.

2. The Education (National Curriculum) (Modern Foreign Languages) Order 1991(c) and the Education (National Curriculum) (Modern Foreign Languages) (Amendment) Order 1994(d) are hereby revoked in relation to Wales.

3.-(1) Yn ddarostyngedig i baragraffau (2) a (3), at ddibenion adran 354 o Ddeddf Addysg 1996 (y pynciau craidd a phynciau sylfaen eraill) ystyr "iaith dramor fodern" yw unrhyw iaith dramor fodern.

(2) Nid yw iaith dramor fodern nad yw'n un o ieithoedd swyddogol y Gymuned Ewropeaidd yn "iaith dramor fodern" at ddibenion adran 354 o Ddeddf Addysg 1996 oni chaiff yr amod ym mharagraff (3) ei fodloni.

(3) Yr amod hwnnw yw bod yr ysgol lle mae'r iaith yn cael ei haddysgu yn cynnig cyfle i bob disgybl yn y trydydd cyfnod allweddol y mae'n ofynnol iddynt astudio iaith dramor fodern fel pwnc sylfaen astudio un neu ragor o ieithoedd swyddogol y Gymuned Ewropeaidd fel pwnc sylfaen.

4.-(1) Caiff unrhyw gwestiwn ynghylch a yw iaith dramor benodol yn iaith dramor fodern at ddibenion adran 354 o Ddeddf Addysg 1996 ei benderfynu gan Gynulliad Cenedlaethol Cymru.

(2) Caiff Cynulliad Cenedlaethol Cymru wneud penderfyniad o dan baragraff (1) yn dilyn cais gan unrhyw berson neu ar ei ysgogiad ei hun.

3.-(1) Subject to paragraphs (2) and (3), for the purposes of section 354 of the Education Act 1996 (the core subjects and other foundation subjects) "modern foreign language" means any modern foreign language.

(2) A modern foreign language which is not an official language of the European Community is not a "modern foreign language" for the purposes of section 354 of the Education Act 1996 unless the condition in paragraph (3) is satisfied.

(3) That condition is that the school at which the language is taught offers all pupils in the third key stage in respect of whom there is a requirement to study a modern foreign language as a foundation subject the opportunity of studying one or more of the official languages of the European Community as a foundation subject.

4.-(1) Any question whether a particular foreign language is a modern foreign language for the purposes of section 354 of the Education Act 1996 shall be determined by the National Assembly for Wales.

(2) The National Assembly for Wales may make a determination under paragraph (1) following an application by any person or on its own initiative.
