EXPLANATORY NOTE

Mae'r Rheoliadau hyn, sy'n gymwys i Gymru'n unig, yn diwygio Rheoliadau Hadau (Ffioedd) 1985 (fel y'u diwygiwyd). Mae'r diwygiad yn darparu ar gyfer codi ffioedd am arholiadau a eisteddir gan arolygwyr cnydau a samplwyr hadau (rheoliad 2).

These Regulations, which apply only to Wales, amend the Seeds (Fees) Regulations 1985 (as amended). The amendment provides for fees to be charged for examinations taken by crop inspectors and seed samplers (regulation 2).

Drwy arfer y pwerau a roddwyd gan adrannau 16(1) ac (1A)(e) o Ddeddf Hadau ac Isrywogaethau Planhigion 1964(a) ac a freiniwyd bellach yng Nghynulliad Cenedlaethol Cymru (“y Cynulliad Cenedlaethol”)(b), ac wedi ymgynghori, yn unol ag adran 16(1) y cyfeiriwyd ati uchod, â chynrychiolwyr y buddiannau hynny a ymddengys i'r Cynulliad Cenedlaethol yn berthnasol, mae'r Cynulliad Cenedlaethol yn gwneud y Gorchymyn canlynol :

In exercise of the powers conferred by sections 16(1) and (1A)(e) of the Plant Varieties and Seeds Act 1964(a) and now vested in the National Assembly for Wales (“the National Assembly”)(b), after consultation in accordance with the said section 16(1) with representatives of such interests as appear to the National Assembly to be concerned, the National Assembly makes the following Order:

Enwi, cychwyn a chymwysu

1. Enw'r Rheoliadau hyn yw Rheoliadau Hadau (Ffioedd) (Diwygio) (Cymru) 2000, maent yn gymwys i Gymru yn unig a deuant i rym ar 7 Mawrth 2000.

Citation, commencement and application

1. These Regulations may be cited as the Seeds (Fees) (Amendment) (Wales) Regulations 2000, shall apply to Wales only and shall come into force on 7th March 2000.

Yna, trosglwyddwyd swyddogaethau'r Ysgrifennydd Gwladol i Gynulliad Cenedlaethol Cymru gan Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672).

(b) By virtue of the Transfer of Functions (Wales) (No. 1) Order 1978 (S.I. 1978/272) the functions of the Minister of Agriculture, Fisheries and Food under the Plant Varieties and Seeds Act 1964 were, so far as they were exercisable in relation to Wales, transferred to the Secretary of State. Those functions of the Secretary of State were then transferred to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672).

2. At the end of Schedule 6 to the Seeds (Fees) Regulations 1985(a) the following wording shall be inserted -
