EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Gorchymyn.)

(This note is not part of the Order.)

Mae'r Gorchymyn hwn yn diwygio Gorchymyn Grantiau Cyfleusterau i'r Anabl a Chymorth Trwsio Cartrefi (Uchafsymiau) 1996 ("Gorchymyn 1996") i'r graddau y mae'n gymwys yng Nghymru.

This Order amends the Disabled Facilities Grants and Home Repair Assistance (Maximum Amounts) Order 1996 ("the 1996 Order") in so far as it applies in Wales.

Mae Gorchymyn 1996, ymhlith pethau eraill, yn rhagnodi uchafswm y cymorth trwsio cartrefi y caiff awdurdod tai lleol ei roi o dan Bennod III o Ran I o Ddeddf Grantiau Tai, Adeiladu ac Adfywio 1996.

The 1996 Order, among other things, prescribes the maximum amount of home repair assistance which a local housing authority may give under Chapter III of Part I of the Housing Grants, Construction and Regeneration Act 1996.

Mae Erthygl 4 o Orchymyn 1996, sy'n rhagnodi uchafswm y cymorth trwsio cartrefi ar gyfer un cais, yn cael ei ddiwygio i godi'r uchafswm hwnnw o £2,000 i £5,000.

Article 4 of the 1996 Order, which prescribes the maximum amount of home repair assistance for one application, is amended to increase that maximum from £2,000 to £5,000.

Mae Erthygl 5 o Orchymyn 1996, sy'n rhagnodi uchafswm y cymorth trwsio cartrefi sy'n daladwy mewn perthynas â'r un annedd, yr un cwch preswyl neu'r un cartref symudol mewn unrhyw gyfnod o dair blynedd, yn cael ei diddymu.

Article 5 of the 1996 Order, which prescribes a maximum amount of home repair assistance payable in respect of the same dwelling, house-boat or mobile home in any period of three years is revoked.

The National Assembly for Wales in exercise of the powers given to it by section 76(2) of the Housing Grants, Construction and Regeneration Act 1996(a), makes the following Order:

Enwi, cychwyn a chymhwyso**Name, commencement and application**

1.-(1) Enw'r Gorchymyn hwn yw Gorchymyn Grantiau Cyfleusterau i'r Anabl a Chymorth Trwsio Cartrefi (Uchafsymiau) (Diwygio) (Cymru) 2001 a daw i rym ar 2 Ebrill 2001.

1.-(1) This Order is called the Disabled Facilities Grants and Home Repair Assistance (Maximum Amounts) (Amendment) (Wales) Order 2001 and it comes into force on 2nd April 2001.

(2) Mae'r Gorchymyn hwn yn gymwys i Gymru yn unig ac nid yw'n effeithiol mewn perthynas â chais am grant cymorth trwsio cartref a wneir cyn y dyddiad y daw i rym.

(2) This Order applies to Wales only and does not have effect in relation to an application for a home repair assistance grant made before the date on which this Order comes into force.

2. Mae Gorchymyn Grantiau Cyfleusteru i'r Anabl a Chymorth Trwsio Cartrefi (Uchafsymiau) 1996(b) yn cael ei ddiwygio yn unol a'r erthyglau canlynol.

2. The Disabled Facilities Grants and Home Repair Assistance (Maximum Amounts) Order 1996(b) is amended in accordance with the following articles.

3. Yn erthygl 4 -

3. In article 4 -

(a) Dilëwch "Subject to article 5";

(a) Delete "Subject to article 5";

(b) -mharagraffau (a) a (b) (ii), yn lle "£2,000" rhowch "£5,000".

(b) In paragraphs (a) and (b) (ii), for "£2,000" substitute "£5,000".

4. Mae Erthygl 5 yn cael ei ddiddymu.
