Mae'r Rheoliadau hyn, sy'n gymwys mewn perthynas â Chymru, yn diwygio Rheoliadau Cynhyrchion sy'n Tarddu o Anifeiliaid (Mewnforio ac Allforio) 1996 (O.S. 1996/1324, fel y'u diwygiwyd) i estyn pwerau swyddogion awdurdodedig mewn perthynas â chynhyrchion sy'n tarddu o anifeiliaid ac sydd wedi'u mewnforio o drydydd gwledydd heblaw yn unol ag amodau iechyd anifeiliaid neu iechyd cyhoeddus.

These Regulations, which apply in relation to Wales, amend the Products of Animal Origin (Import and Export) Regulations 1996 (S.I. 1996/1324, as amended) so as to extend the powers of authorised officers as regards products of animal origin which have been imported from third countries otherwise than in accordance with animal or public health conditions.

Title, application and commencement

1.These Regulations are called the Products of Animal Origin (Import and Export) (Amendment) (Wales) Regulations 2001; they apply in relation to Wales and come into force at 7.30 p.m. on 2nd May 2001.

2.-(1) The Products of Animal Origin (Import and Export) Regulations 1996(c) in so far as they apply in relation to Wales are amended in accordance with the following paragraphs of this regulation.
