Mae'r Rheoliadau hyn, sy'n gymwys i Gymru yn unig, yn diwygio Rheoliadau Ychwanegion Bwyd Amrywiol 1995, fel y'u diwygiwyd ("y prif Reoliadau").

Mae'r Rheoliadau yn gweithredu Cyfarwyddeb y Comisiwn 2000/63/EC sy'n diwygio Cyfarwyddeb 96/77/EC sy'n nodi meinu prawf purdeb penodol ynghylch ychwanegion bwyd heblaw lliwiau a melysyddion (OJ Rhif L277, 30.10.2000, t.1).

Yn ddarostyngedig i ddarpariaeth drosiannol, mae'r Rheoliadau yn diwygiao'r gofynion presennol yn y prif Reoliadau o ran y meinu prawf purdeb ar gyfer butylated hydroxyanisole (BHA) ac yn pennu meinu prawf purdeb newydd mewn perthynas â'r ychwanegion a bennir yn Atodiad II i Gyfarwyddeb y Comisiwn 2000/63/EC (rheoliadau 3 i 5).

Mae'r Rheoliadau yn gwneud diwygiadau canlyniadol hefyd i'r offerynnau a bennir yn rheoliad 4, o ran cyfeiriadau yn yr offerynnau hynny at y prif Reoliadau (rheoliad 6).

Nid oes unrhyw arfarniad rheoliadol wedi'i baratoi ar gyfer y Rheoliadau hyn.

The Miscellaneous Food Additives (Amendment) (Wales) Regulations 2001

### EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations, which apply to Wales only, amend the Miscellaneous Food Additives Regulations 1995, as amended ("the principal Regulations").

The Regulations implement Commission Directive 2000/63/EC amending Directive 96/77/EC laying down specific purity criteria on food additives other than colours and sweeteners (OJ No. L277, 30.10.2000, p.1).

Subject to a transitional provision, the Regulations amend the existing requirements in the principal Regulations as regards the purity criteria for butylated hydroxyanisole (BHA) and specify new purity criteria in relation to the additives specified in Annex II to Commission Directive 2000/63/EC (regulations 3 to 5).

The Regulations also make consequential amendments to the instruments specified in regulation 4, as regards references in those instruments to the principal Regulations (regulation 6).

No regulatory impact assessment has been prepared in respect of these Regulations.

Drwy arfer y pwerau a roddwyd gan adrannau 16(1)(a), 17(1), 26(1) and (3) a 48(1) o Ddeddf Diogelwch Bwyd 1990(a), a pharagraff 1 o Atodlen 1 iddi, ac sydd wedi'u breinio bellach yng Nghynulliad Cenedlaethol Cymru, mae Cynulliad Cenedlaethol Cymru(b), ar ôl rhoi sylw, yn unol ag adran 48(4A) o'r Ddeddf honno, i gyngor perthnasol a roddwyd gan yr Asiantaeth Safonau Bwyd, ac ar ôl ymgynghori yn unol ag adran 48(4) a (4B) o'r Ddeddf honno, yn gwneud y Rheoliadau canlynol:

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Ychwanegion Bwyd Amrywiol (Diwygio) (Cymru) 2001.

(2) Mae'r Rheoliadau hyn yn gymwys i Gymru yn unig a deuant i rym ar 1 Mehefin 2001.

In exercise of the powers conferred by sections 16(1)(a), 17(1), 26(1) and (3) and 48(1) of, and paragraph 1 of Schedule 1 to, the Food Safety Act 1990 (a), and now vested in the National Assembly for Wales (b) the National Assembly for Wales, having had regard, in accordance with section 48(4A) of that Act to relevant advice given by the Food Standards Agency, and after consultation in accordance with section 48(4) and (4B) of that Act, makes the following Regulations:

**Title, commencement, and application**

1.-(1) These Regulations may be cited as the Miscellaneous Food Additives (Amendment) (Wales) Regulations 2001.

(2) These Regulations apply to Wales only and come into force on 1st June 2001.

Mae Rheoliad 13(4) o O.S. 2000/656 yn awdurdodi'r Ysgrifennydd Gwladol yn ddiamwys i ddiwygio'r Rheoliadau sy'n bodoli eisoes ac a wnaed gan y Gweinidog Amaethyddiaeth, Pysgodfeydd a Bwyd (p'un ai gydag eraill neu beidio) o dan Ddeddf Diogelwch Bwyd 1990.

2. Diwygir Rheoliadau Ychwanegion Amrywiol bwyd 1995 (a) i'r graddau y maent yn gymwys i Gymru, yn unol â Rheoliadau 3 i 5 isod.

3. Yn rheoliad 2(1) (dehongli), yn y diffiniad o "Directive 96/77/EC" ychwanegir y geiriau "and Commission Directive 2000/63/EC"(b) ar y diwedd.

4. Yn rheoliad 11 (darpariaeth drosiannol ac esemttiadau) mewnosodir ar ôl paragraff (1B) y paragraff canlynol -

" (1C) In any proceedings for an offence under these Regulations in respect of any food additive or food, it shall be a defence to prove

that -

- (a) the food additive or food concerned was put on the market or labelled before 1st June 2001; and
- (b) the matter constituting the offence would not have constituted an offence under these Regulations if the amendments made by regulations 3 and 5 of the Miscellaneous Food Additives (Amendment) (Wales) Regulations 2001 had not been made when that matter occurred.”.

6.-(1) I'r graddau y mae unrhyw offeryn a restrir yn rheoliad 14(1) o Reoliadau Ychwanegion Bwyd Amrywiol (Diwygio) 1999(c) yn gymwys i Gymru, bydd effaith y ddarpariaeth honno yn dod i ben mewn perthynas â'r offeryn hwnnw.

(2) Yn yr offerynnau canlynol, i'r graddau y maent yn gymwys i Gymru, dehonglir cyfeiriadau at Reoliadau Ychwanegion Bwyd Amrywiol 1995 fel petaent yn gyfeiriadau at yr offerynnau hynny fel y'u diwygiwyd gan Reoliadau Ychwanegion Bwyd (Diwygio) 1997(ch), Rheoliadau Ychwanegion Bwyd Amrywiol (Diwygio) 1999 a'r Rheoliadau hyn:

## Amendment of the Miscellaneous Food Additives Regulations 1995

2. The Miscellaneous Food Additives Regulations 1995 (a) shall be amended in so far as they apply to Wales, in accordance with Regulations 3 to 5 below.

3. In regulation 2(1) (interpretation), in the definition of "Directive 96/77/EC" there shall be added at the end the words "and Commission Directive 2000/63/EC"(b).

4. In regulation 11 (transitional provision and exemptions) there shall be inserted after paragraph (1B) the following paragraph -

" (1C) In any proceedings for an offence under these Regulations in respect of any food additive or food, it shall be a defence to prove

that -

- (a) the food additive or food concerned was put on the market or labelled before 1st June 2001; and
- (b) the matter constituting the offence would not have constituted an offence under these Regulations if the amendments made by regulations 3 and 5 of the Miscellaneous Food Additives (Amendment) (Wales) Regulations 2001 had not been made when that matter occurred.”.

5. In Schedule 5 (purity criteria) the entries relating to the miscellaneous additives listed in the Schedule to these Regulations shall be omitted.

## Consequential amendments

6.-(1) In so far as any Instrument listed in regulation 14(1) of the Miscellaneous Food Additives (Amendment) Regulations 1999(c) extends to Wales, that provision shall cease to have effect in relation to that instrument.

(2) In the following instruments, in so far as they extend to Wales, references to the Miscellaneous Food Additives Regulations 1995 shall be construed as references to those instruments as amended by the Miscellaneous Food Additives (Amendment) Regulations 1997(d), the Miscellaneous Food Additives (Amendment) Regulations 1999 and these Regulations:
