### **NODYN ESBONIADOL**

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Addysg (Lleoedd a Gynorthwyir) 1997 ("Rheoliadau 1997") mewn perthynas â blwyddyn ysgol yn dechrau ar 1 Medi 2001 neu wedyn. Mae Rheoliadau 1997 yn rhagnodi trefniadau ar gyfer disgylion sy'n gymwys i barhau i gael lleoedd a gynorthwyir mewn ysgolion annibynnol yn rhinwedd adran 2 o Ddeddf Addysg (Ysgolion) 1997, er bod y cynllun cymorth lleoedd wedi'i ddileu gan adran 1 o'r Ddeddf honno.

Mae'r swm sydd i'w dynnu yn yr incwm "perthnasol" mewn perthynas â pherthnasau dibynnol o dan reoliad 10(4) a (6) o Reoliadau 1997 yn cael ei gynyddu o £1,400 i £1,430.

Ar lefel incwm benodol, neu o dan y lefel honno, nid yw'r ffioedd yn cael eu casglu o gwbl. Mae'r lefel honno yn cael ei chynyddu i £11,116 yn lle £10,901, gyda chynnydd cyfatebol yn y swm nad yw'n cael ei gasglu os yw'r incwm "perthnasol" yn fwy na'r swm hwnnw.

### **EDUCATION, WALES**

The Education (Assisted Places) (Amendment) (Wales) Regulations 2001

### **EXPLANATORY NOTE**

(*This note is not part of the Regulations*)

These Regulations amend the Education (Assisted Places) Regulations 1997 ("the 1997 Regulations") in respect of a school year beginning on or after 1st September 2001. The 1997 Regulations prescribe arrangements for pupils who are eligible to continue to hold assisted places at independent schools by virtue of section 2 of the Education (Schools) Act 1997, notwithstanding the abolition of the assisted places scheme by section 1 of that Act.

The deduction to be made in "relevant" income in respect of dependent relatives under regulation 10(4) and (6) of the 1997 Regulations is increased from £1,400 to £1,430.

The level of income at or below which fees are to be wholly remitted is set at £11,116 instead of £10,901, with corresponding increases in the extent of remission where "relevant" income exceeds that sum.

Mae Cynulliad Cenedlaethol Cymru wedi ymgynghori, yn unol ag adran 3(7) o Ddeddf Addysg (Ysgolion) 1997(a), â'r cyrff hynny y mae'n ymddangos iddo eu bod yn briodol ac â chynrychiolyddion ysgolion sy'n darparu lleoedd a gynorthwyir o dan adran 2(1) o'r Ddeddf honno.

Drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adran 3(1), (2), (5) a (9) o'r Ddeddf honno ac sydd bellach wedi'u breiniio yng Nghynulliad Cenedlaethol Cymru(b), mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol:

**Enwi, cychwyn a chymhwysyo**

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Addysg (Lleoedd a Gynorthwyir) (Diwygio) (Cymru) 2001 a deuant i rym ar 1 Medi 2001.

(2) Mae'r Rheoliadau hyn yn gymwys i Gymru yn unig.

(3) Mae'r Rheoliadau hyn yn gymwys mewn perthynas ag unrhyw flwyddyn ysgol sy'n dechrau ar 1 Medi 2001 neu wedyn.

**Diwygio Rheoliadau Addysg (Lleoedd a Gynorthwyir) 1997**

2.-(1) Diwygir Rheoliadau Addysg (Lleoedd a Gynorthwyir) 1997(c) fel a ganlyn.

(2) Yn rheoliad 10(4) a (6), yn lle "£1,400" ym mhob man lle y'i gwelir, rhoddir "£1,430".

**2001 No. 2680 (W.221)****EDUCATION, WALES****The Education (Assisted Places) (Amendment) (Wales) Regulations 2001***Made**17th July 2001**Coming into force**1st September 2001*

The National Assembly for Wales has consulted, in accordance with section 3(7) of the Education (Schools) Act 1997(a), such bodies as appear to it to be appropriate and representatives of schools which provide assisted places under section 2(1) of that Act.

In exercise of the powers conferred on the Secretary of State by section 3(1), (2), (5) and (9) of that Act and now vested in the National Assembly for Wales(b), the National Assembly for Wales makes the following Regulations:

**Citation, commencement and application**

1.-(1) These Regulations may be cited as the Education (Assisted Places) (Amendment) (Wales) Regulations 2001 and shall come into force on 1st September 2001.

(2) These Regulations apply to Wales only.

(3) These Regulations apply in relation to any school year beginning on or after 1st September 2001.

**Amendment of the Education (Assisted Places) Regulations 1997**

2.-(1) The Education (Assisted Places) Regulations 1997(c) shall be amended as follows.

(2) In regulation 10(4) and (6), for "£1,400" in each place where it appears there shall be substituted "£1,430".

(b) The functions of the Secretary of State under section 3 were transferred to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672).

(3) Ym mharagraff 1 o Atodlen 2, yn lle "£10,901" rhoddir "£11,116".

(4) Yn lle'r tabl sy'n dilyn paragraff 2(1) o'r Atodlen honno, rhoddir y tabl canlynol -

(3) In paragraph 1 of Schedule 2, for "£10,901" there shall be substituted "£11,116".

(4) For the table following paragraph 2(1) of that Schedule there shall be substituted the following table -
