1. Mae'r Rheoliadau hyn, sy'n gymwys i Gymru yn unig ac yn dod i rym ar 3 Tachwedd 2001, yn diwygio Rheoliadau Porthiant (Cymru) 2001 a Rheoliadau Porthiant (Gorfodi) 1999 i'r graddau y maent yn gymwys i Gymru.

2. Mae'r Rheoliadau'n gweithredu -

- (a) Penderfyniad y Comisiwn 2000/285/EC sy'n diwygio Penderfyniad 91/516/EC a sefydlodd restr o gynhwysion y gwaherddir eu defnyddio mewn porthiant (OJ Rhif L94, 14.4.2000, t. 43), a
- (b) Cyfarwyddeb 2000/16/EC y Senedd Ewropeaidd a'r Cyngor sy'n diwygio Cyfarwyddeb 79/373/EC ynghylch marchnata porthiant cyfansawdd (OJ Rhif L105, 3.5.2000, t. 36), a
- (c) Cyfarwyddeb y Cyngor 96/25/EC ynghylch cylchrededg deunyddiau porthiant (OJ Rhif 125, 23.5.1996, t.35).

3. Mae'r Rheoliadau -

- (a) yn diwygio mesurau ynghylch marchnata porthiant cyfansawdd a chylchredeg deunyddiau porthiant (rheoliad 6);
- (b) yn diwygio mesurau ynghylch rheoli porthiant cyfansawdd er mwyn gwahardd defnyddio deunydd o brosesau trin gwastraff (rheoliad 10);
- (c) yn ychwanegu'r tri Rheoliad Comisiwn newydd (sy'n gymwysadwy yn uniongyrchol)

## AGRICULTURE, WALES

### The Feeding Stuffs and the Feeding Stuffs (Enforcement) (Amendment) (Wales) Regulations 2001

### EXPLANATORY NOTE

(*This note does not form part of the Regulations*)

1. These Regulations, which apply to Wales only and come into force on 3rd November 2001, amend the Feeding Stuffs (Wales) Regulations 2001 and the Feeding Stuffs (Enforcement) Regulations 1999 insofar as they apply to Wales.

2. The Regulations implement -

- (a) Commission Decision 2000/285/EC amending Decision 91/516/EC which established a list of ingredients whose use is prohibited in feedingstuffs (OJ No. L94, 14.4.2000, p. 43), and
- (b) Directive 2000/16/EC of the European Parliament and of the Council amending Directive 79/373/EC on the marketing of compound feedingstuffs (OJ No. L105, 3.5.2000, p. 36), and
- (c) Council Directive 96/25/EC on the circulation of feed materials (OJ No. 125, 23.5.1996, p.35).

3. The Regulations -

- (a) modify measures on the marketing of compound feed stuffs and the circulation of feed materials (regulation 6);
- (b) modify measures on the control of compound feeding stuffs to prohibit the use of material from waste treatment processes (regulation 10);
- (c) add the three new (directly applicable) Commission Regulations specified below to

The Feeding Stuffs and the Feeding Stuffs (Enforcement) (Amendment) (Wales) Regulations 2001

Coming into force*

*16th October 2001  
3rd November 2001*

In exercise of the powers conferred on Ministers of the Crown by sections 66(1), 68(1) and (1A), 69(1), 74A and 84 of the Agriculture Act 1970(a), which are now exercisable in Wales by the National Assembly for Wales(b), and after consultation as required by section 84(1) of that Act with the persons or organisations appearing to represent the interests concerned, and being designated(c) for the purposes of section 2(2) of the European Communities Act 1972(d) in relation to the common agricultural policy of the European Community, in exercise of the powers conferred on it by the said section 2(2)(e) (in so far as these Regulations cannot be made under the powers in the Agriculture Act 1970 specified above), the National Assembly for Wales makes the following Regulations:

**Title, application and commencement**

- These Regulations may be cited as the Feeding Stuffs and the Feeding Stuffs (Enforcement) (Amendment) (Wales) Regulations 2001, shall apply to Wales only and shall come into force on 3rd November 2001.

**Amendment of the Feeding Stuffs (Wales) Regulations 2001**

- The Feeding Stuffs (Wales) Regulations 2001(f)

**3. In regulation 2 (interpretation) -**

**(a) in paragraph (1) -**

- (i) after the definition of "European Economic Area Agreement" there shall be inserted the following definitions-

"European Economic Area approved Article 2.2(d) establishment" ("sefydliad a gymeradwywyd gan Ardal Economaidd Ewrop ar gyfer Erthyg 2.2(d)") means an establishment listed on a register of approved establishments, maintained by a competent authority in a European Economic Area state which is neither the United Kingdom nor a member State, in implementation of Article 5 of the Establishments Directive, as an establishment on which a compound feeding stuff, of any kind the manufacture of which is regulated by Article 2.2(d) of that Directive, may be manufactured with a view to putting it into circulation;" European Economic Area approved Article 2.2(f) establishment" ("sefydliad a gymeradwywyd gan Ardal Economaidd Ewrop ar gyfer Erthygl 2.2(f)") means an establishment listed on a register of approved establishments, maintained by a competent authority in a European Economic Area state which is neither the United Kingdom nor a member State, in implementation of Article 5 of the Establishments Directive, as an establishment on which a compound feeding stuff, of any kind the production of which is regulated by Article 2.2(f) of that Directive, may be produced for the exclusive requirements of the producer's holding;

"European Economic Area permitted Article 2.2(d) establishment" ("sefydliad a ganiateir gan Ardal Economaidd Ewrop ar gyfer Erthygl 2.2(d)") means an establishment located in a European Economic Area state which is neither the United Kingdom nor a member State (other than an European Economic Area approved Article 2.2(d) establishment or an establishment which a competent authority in that European Economic Area state has declined to approve as such an establishment) -

- (a) on which a compound feeding stuff, of any kind the manufacture of which is regulated by Article 2.2(d) of the Establishments Directive, was being manufactured, with a view to putting it into circulation, on 10th March

- 2000, and
- (b) in respect of which, before 10th August 2000, an application (which is pending) was made to a competent authority in the European Economic Area state concerned, in accordance with any requirements in that State for the making of such applications, to approve the establishment, pursuant to the Establishments Directive, as an establishment on which a compound feeding stuff of any such kind may be manufactured with a view to putting it into circulation;
- "European Economic Area permitted Article 2.2(f) establishment" ("sefydliad a ganiateir gan Ardal Economaidd Ewrop ar gyfer Erthygl 2.2(f)") means an establishment located in a European Economic Area state which is neither the United Kingdom nor a member State (other than a European Economic Area approved Article 2.2(f) establishment or an establishment which a competent authority in that European Economic Area state has declined to approve as such an establishment) -
- (a) on which a compound feeding stuff, of any kind the production of which is regulated by Article 2.2(f) of the Establishments Directive, was being produced, for the exclusive requirements of the producer's holding, on 10th March 2000, and
- (b) in respect of which before 10th August 2000, an application (which is pending) was made to a competent authority in the European Economic Area state concerned, in accordance with any requirements in that State for the making of such applications, to approve the establishment, pursuant to the Establishments Directive, as an establishment on which a compound feeding stuff of any such kind may be produced for the exclusive requirements of the producer's holding;"
- (ii) for the definition of "put into circulation", there shall be substituted the following definition -
- ""put into circulation" ("rhoi mewn cylchrediad") means sell or otherwise transfer, have in possession with a view to selling or otherwise transferring, or offer for sale, to a third party, but, in regulation 14(3), (4) and (7), also means import into Wales from a country which is neither an European Economic Area state nor part of an European Economic Area state;" and

- (iii) yn lle'r diffiniad o "trydedd wlad" rhoddir y diffiniad canlynol -"ystyr "trydedd wlad" ("third country") yw gwlad heblaw un o wladwriaethau Ardal Economaidd Ewrop;";
- (b) hepgorir paragraff (2) ac
- (c) ym mharagraff (8), yn lle'r geiriau "gwneud y Rheoliadau hyn" rhoddir y geiriau "gwneud Rheoliadau Porthiant a Rheoliadau Porthiant (Gorfodi) (Diwygio) (Cymru) 2001".

**4.-(1)** Ym mhob un o'r darpariaethau a bennir ym mharagraff (2) isod, ar ôl y geiriau "Rheoliadau Porthiant (Cymru) 2001" ychwanegir y geiriau "fel y'u diwygiwyd gan Reoliadau Diwygio Porthiant a Rheoliadau Porthiant (Gorfodi) (Cymru) 2001".

(2) Y darpariaethau y cyfeirir atynt ym mharagraff (1) uchod yw rheoliadau 7(1), 24(1) a 25(b).

**5.** Yn rheoliad 7 (cyfyngu amrywiadau), yn lle paragraff (3)(a) a (b) rhoddir y paragraffau canlynol -

- "(a) os cafodd y deunydd ei werthu gyntaf, neu ei roi mewn cylchrediad fel arall, mewn Aelod-wladwriaeth neu yn un o wladwriaethau Ardal Economaidd Ewrop (heblaw'r Deyrnas Unedig) nad yw'n Aelod-wladwriaeth,
- (b) os nad oedd y cam-ddatganiad, adeg rhoi'r deunydd mewn cylchrediad, y tu hwnt i unrhyw gyfyngiadau ar amrywiadau a ragnodwyd mewn perthynas ag ef yn y wladwriaeth o dan sylw, ac".

**6.** Yn rheoliad 9 (dull pacio a selio porthiant cyfansawdd, ychwanegion a rhag-gymysgeddau) -

- (a) ym mharagraff (1), yn lle'r geiriau "ni chaiff neb werthu porthiant cyfansawdd, nac unrhyw ychwanegyn neu rag-gymysgedd" rhoddir y geiriau "ni chaiff neb werthu porthiant cyfansawdd, na gwerthu unrhyw ychwanegyn neu rag-gymysgedd";
- (b) ym mhob un o baragraffau (2) a (3), yn lle'r geiriau "ei werthu" rhoddir y geiriau "ei roi mewn cylchrediad"; ac
- (c) ym mharagraff 2(a), yn lle'r geiriau "neu werthwyr porthiant cyfansawdd" rhoddir y geiriau "porthiant cyfansawdd neu'r sawl sy'n ei roi mewn cylchrediad".

**7.-(1)** Ym mhob un o'r darpariaethau a bennir ym mharagraff (2) isod, yn lle'r geiriau "gwerthu unrhyw borthiant cyfansawdd sy'n cynnwys unrhyw ddeunydd porthiant o'r fath, na'i feddianu gyda golwg ar ei werthu," rhoddir y geiriau "rhoi unrhyw borthiant

- (iii) for the definition of "third country" there shall be substituted the following definition -  
""third country" ("trydedd wlad") means a country other than an European Economic Area state;";
- (b) paragraph (2) shall be omitted; and
- (c) in paragraph (8), for the words "these Regulations are made" there shall be substituted the words "the Feeding Stuffs and the Feeding Stuffs (Enforcement) (Amendment) (Wales) Regulations 2001 are made".

**4.-(1)** In each of the provisions specified in paragraph (2) below, after the words "the Feeding Stuffs (Wales) Regulations 2001" there shall be added the words "as amended by the Feeding Stuffs and the Feeding Stuffs (Enforcement) (Amendment) (Wales) Regulations 2001".

(2) The provisions referred to in paragraph (1) above are regulations 7(1), 24(1) and 25(b).

**5.** In regulation 7 (limits of variation), for paragraph (3)(a) and (b) there shall be substituted the following paragraphs -

- "(a) the material was first sold, or otherwise put into circulation, in a member State or in a European Economic Area state (other than the United Kingdom) which is not a member State,
- (b) the mis-statement did not, at the time of putting into circulation, exceed any limits of variation prescribed in relation thereto in the State concerned, and".

**6.** In regulation 9 (manner of packaging and sealing compound feeding stuffs, additives and premixtures) -

- (a) in paragraph (1), for the words "no person shall sell a compound feeding stuff, or any additive or premixture" there shall be substituted the words "no person shall put into circulation a compound feeding stuff, or sell any additive or premixture";
- (b) in each of paragraphs (2) and (3), for the word "sold" there shall be substituted the words "put into circulation"; and
- (c) in paragraph 2(a), for the words "or sellers of compound feeding stuffs" there shall be substituted the words "of compound feeding stuffs or those putting them into circulation".

"(8) If the National Assembly for Wales is of the opinion that, in any area covered by an enforcement authority, the Feeding Stuffs (Wales) Regulations 2001, (as amended by the Feeding Stuffs and the Feeding Stuffs (Enforcement) (Amendment) (Wales) Regulations 2001), or section 73 or 73A of this Act, have been -

- (a) insufficiently enforced or administered by the authority concerned, or
- (b) enforced or administered by it without sufficient regard to the requirements of Council Directive 95/53/EC fixing the principles governing the organisation of official inspections in the field of animal nutrition, as amended by Council Directive 1999/20/EC,

it may appoint one or more inspectors to exercise the powers exercisable by inspectors appointed by the authority in question, and any expenses certified by it as having been incurred by it under this subsection shall be repaid to it on demand by that authority." (a); and

- (c) in regulation 10, in subsection (17) of section 76 of the Agriculture Act 1970 as modified by that regulation, for the references to "the Feeding Stuffs Regulations 1995" there shall be substituted references to "the Feeding Stuffs (Wales) Regulations 2001 as amended by the Feeding Stuffs and the Feeding Stuffs (Enforcement) (Amendment) (Wales) Regulations 2001".
