EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

Mae'r Rheoliadau'n gwneud mân ddiwygiadau i Reoliadau Cyfrifon ac Archwilio 1996 sydd, er eu bod wedi gwneud o dan ddeddfwriaeth flaenorol, wedi parhau mewn grym yn rhinwedd paragraff 2 o Atodlen 4 i Ddeddf y Comisiwn Archwilio 1998 (mesur cydgrynhoi).

The Regulations make minor amendments to the Accounts and Audit Regulations 1996, which, although made under the previous legislation, were continued in force by virtue of paragraph 2 of Schedule 4 to the Audit Commission Act 1998 (a consolidation measure).

Mae Rheoliad 3 yn diwygio Rheoliad 6 o Reoliadau 1996 er mwyn hepgor y cyfeiriad at "a probation committee". Yn Neddf Cyfiawnder Troseddol a Gwasanaethau Llys 2000 gwelwyd disodli pwyllgorau prawf â byrddau prawf, nad ydynt yn dod o dan Reoliadau 1996.

Regulation 3 amends Regulation 6 of the 1996 Regulations so as to omit the reference to "a probation committee". The Criminal Justice and Court Services Act 2000 saw the replacement of probation committees with probation boards, which are not subject to the 1996 Regulations.

Mae Rheoliad 4 yn diwygio Rheoliad 7 o Reoliadau 1996 i godi'r trothwy ariannol lle y mae'n ofynnol i'r cynghorau cymuned yng Nghymru baratoi cyfrifon incwm a gwariant o £5,000 i £50,000.

Regulation 4 amends Regulation 7 of the 1996 Regulations to increase the financial threshold above which community councils in Wales are required to prepare income and expenditure accounts from £5,000 to £50,000.

Mae Rheoliad 5 yn mewnosod gofyniad newydd yn Rheoliadau 1996, sef bod y cyrff perthnasol yn cyhoeddi'r llythyr archwilio blynyddol a gânt oddi wrth eu harchwilydd.

Regulation 5 inserts a new requirement into the 1996 Regulations for relevant bodies to publish the annual audit letter that they receive from their auditor.

Mae Cynulliad Cenedlaethol Cymru yn gwneud y rheoliadau canlynol drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adran 27 o Ddeddf y Comisiwn Archwilio 1998(a) sydd bellach wedi'u breinio yng Nghynulliad Cenedlaethol Cymru i'r graddau y maent yn arferadwy yng Nghymru (b) ac ar ôl ymgynghori â'r Comisiwn Archwilio, unrhyw gymdeithasau awdurdodau lleol y mae'n ymddangos iddo eu bod yn berthnasol ac unrhyw gyrff cyfrifwyr y mae'n ymddangos iddo eu bod yn briodol:

The National Assembly for Wales makes the following regulations in exercise of the powers given to the Secretary of State by section 27 of the Audit Commission Act 1998(a) which are now vested in the National Assembly for Wales in so far as exercisable in Wales(b) and after consulting the Audit Commission, such associations of local authorities as appear to it to be concerned and such bodies of accountants as appear to it to be appropriate:

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Cyfrifon ac Archwilio (Diwygio) (Cymru) 2001 a deuant i rym ar 18 Ionawr 2002.

Name, commencement and application

1.-(1) The name of these Regulations is the Accounts and Audit (Amendment) (Wales) Regulations 2001 and they shall come into force on 18 January 2002.

(2) These Regulations apply to Wales only.

2. Yn y rheoliadau hyn ystyr "Rheoliadau 1996" ("the 1996 Regulations") yw Rheoliadau Cyfrifon ac Archwilio 1996(c).

Interpretation

2. In these regulations "the 1996 Regulations" ("the 1996 Regulations") means the Accounts and Audit Regulations 1996(c).

- (b) keep copies available for purchase by any person on payment of a reasonable sum to be determined by the relevant body."

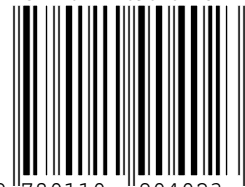
