Mae'r Gorchymyn hwn yn rhoi i Awdurdod Cymwysterau, Cwricwlwm ac Asesu Cymru ("ACCAC") y swyddogaeth, sydd i'w harfer gan ACCAC yn unig, o wneud trefniadau ar gyfer datblygu, gosod a gweinyddu profion sydd i'w sefyll gyda golwg ar ennill pob cymhwyster allanol (ac eithrio Cymwysterau Galwedigaethol Cenedlaethol).

This Order confers on the Qualifications, Curriculum and Assessment Authority for Wales ("ACCAC") the function, to be solely exercised by ACCAC, of making arrangements for developing, setting and administering tests which are to be taken with a view to obtaining all external qualifications (excluding National Vocational Qualifications).

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Gorchymyn canlynol drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 24(3) a 30(1) o Ddeddf Addysg 1997(a) ac sydd bellach wedi'u breinio yng Nghynulliad Cenedlaethol Cymru(b).

The National Assembly for Wales makes the following Order in exercise of the powers conferred on the Secretary of State by sections 24(3) and 30(1) of the Education Act 1997(a) and now vested in the National Assembly for Wales(b).

Enwi a chychwyn

1. Enw'r Gorchymyn hwn yw Gorchymyn Addysg (Awdurdod Cymwysterau, Cwricwlwm ac Asesu Cymru) (Rhoi Swyddogaeth) 2001 a daw i rym ar 31 Rhagfyr 2001.

Citation and commencement

1. This Order is called the Education (Qualifications, Curriculum and Assessment Authority for Wales) (Conferment of Function) Order 2001 and shall come into force on 31st December 2001.

Dehongli

2. Yn y Gorchymyn hwn -

ystyr "ACCAC" ("*ACCAC*") yw Awdurdod Cymwysterau, Cwricwlwm ac Asesu Cymru(c); ac

ystyr "Deddf 1997" ("*the 1997 Act*") yw Deddf Addysg 1997.

Interpretation

2. In this Order -

"the 1997 Act" ("*Deddf 1997*") means the Education Act 1997; and

"ACCAC" ("*ACCAC*") means the Qualifications, Curriculum and Assessment Authority for Wales(c).

Rhoi swyddogaeth

3.-(1) Mewn perthynas â chymwysterau o'r fath a bennir ym mharagraff (2) isod, rhoir y swyddogaeth o fewn paragraff (gg) o adran 24(2) o Ddeddf 1997 i ACCAC.

Conferment of function

3.-(1) The function falling within paragraph (gg) of section 24(2) of the 1997 Act is, in relation to qualifications of the kind specified in paragraph (2) below, conferred on ACCAC.

(a) 1997 p.44. Mewnysodwyd paragraff newydd (gg) yn is-adran (2) o adran 24 o'r Ddeddf honno gan is-adran (2) o adran 103 o Ddeddf Dysgu a Medrau 2000 (p.21) a diwygiwyd adran 30(2) o Ddeddf 1997 gan adran 103(3) o Ddeddf 2000 i gynnwys cyfeiriad at yr adran 24(2)(gg) newydd yn Neddf 1997.

(b) Gweler Gorchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672) ac adran 150 o Ddeddf Dysgu a Medrau 2000.

(c) Sefydlwyd Awdurdod Cymwysterau, Cwricwlwm ac Asesu Cymru gan adran 14(1)(b) o Ddeddf Diwygio Addysg 1988 (p.40), parhaodd mewn bodolaeth yn rhinwedd adran 360 o Ddeddf Addysg 1996 (p.56) a rhoddwyd ei enw cyfredol iddo gan adran 27(1) o Ddeddf Addysg 1997.

(a) 1997 c.44. A new paragraph (gg) is inserted in subsection (2) of section 24 of that Act by subsection (2) of section 103 of the Learning and Skills Act 2000 (c.21) and section 30(2) of the 1997 Act is amended by section 103(3) of the 2000 Act to include reference to the new section 24(2)(gg) of the 1997 Act.

(b) See the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672) and section 150 of the Learning and Skills Act 2000.

(c) The Qualifications, Curriculum and Assessment Authority for Wales was established by section 14(1)(b) of the Education Reform Act 1988 (c.40), continued in existence by section 360 of the Education Act 1996 (c.56) and given its current name by section 27(1) of the Education Act 1997.

(2) Y cymwysterau hynny yw pob cymhwyster allanol ar wahân i Gymwysterau Galwedigaethol Cenedlaethol.

(3) Mae'r swyddogaeth a roddir gan yr erthygl hon yn cael ei rhoi i fod yn arferadwy gan ACCAC yn unig.

(2) Those qualifications are all external qualifications except National Vocational Qualifications.

(3) The function conferred by this article is conferred so as to be exercisable solely by ACCAC.
