Mae'r Rheoliadau hyn yn darparu, at ddibenion y swyddogaeth sydd gan Gyngor Gofal Cymru o dan adran 54(3) o Ddeddf Safonau Gofal 2000 ('y Ddeddf) yn unig, fod personau penodol i'w trin fel gweithwyr gofal cymdeithasol. O dan adran 54(3) o'r Ddeddf rhaid i Gyngor Gofal Cymru hyrwyddo mewn perthynas â Chymru safonau ymddygiad a safonau ymarfer uchel ymhlið gweithwyr gofal cymdeithasol, a safonau uchel ar gyfer eu hyfforddiant.

Y personau a ddisgrifir yn is-baragraffau (a) i (g) o adran 55(3) o'r Ddeddf yw'r rhai sydd i'w trin fel gweithwyr gofal cymdeithasol at y dibenion sydd newydd eu crybwyl. Maent yn cynnwys personau sy'n ymgymryd â gwaith at ddibenion swyddogaethau gwasanaethau cymdeithasol awdurdod lleol (neu â darparu gwasanaethau sy'n debyg i'r rhai sy'n cael eu darparu wrth arfer y swyddogaethau hynny); personau sy'n ymgymryd â darparu gofal personol i unrhyw berson; personau penodol sy'n ymwneud ag asiantaethau gwaith cymdeithasol; personau sy'n cael eu cyflogi mewn canolfannau dydd; a myfyrwyr penodol sy'n astudio gwaith cymdeithasol.

### **EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations provide that for the purposes only of the function of the Care Council for Wales under section 54(3) of the Care Standards Act 2000 ('the Act') certain persons are to be treated as social care workers. Under section 54(3) of the Act the Care Council for Wales shall promote in relation to Wales high standards of conduct and practice among social care workers, and high standards in their training.

The persons who are to be treated as social care workers for the purposes just mentioned are those described in sub-paragraphs (a) to (g) of section 55(3) of the Act. Those include persons engaged in work for the purposes of a local authority's social services functions (or in the provision of services similar to those provided in the exercise of those functions); persons engaged in the provision of personal care for any person; certain persons involved with social work agencies; persons employed in day centres; and certain social work students.

The National Assembly for Wales, in exercise of the  
powers conferred upon it by sections 55(3) and 118(5)  
and (6) of the Care Standards Act 2000(a) hereby  
makes the following Regulations:

**Citation, commencement and application**

1.-(1) These Regulations may be cited as the Care  
Standards Act 2000 (Extension of Meaning of "Social  
Care Worker") (Wales) Regulations 2002 and shall  
come into force on 30th April 2002.

(2) These Regulations apply in relation to Wales.

**Interpretation****2. In these Regulations-**

"the Act" means the Care Standards Act 2000;  
"the Council" means the Care Council for  
Wales established by section 54(1) of the Act.

**Persons to be treated as social care workers**

3. For the purposes only of the function of the  
Council under section 54(3) of the Act persons of any  
of the descriptions in sub-paragraphs (a) to (g) of  
paragraph (3) of section 55 of the Act are to be treated  
as social care workers.

(a) 2000 c.14. The powers are exercisable by the appropriate Minister.  
The appropriate Minister is defined in section 121(1). It means the  
Assembly in relation to Wales (section 5(b) provides that "the  
Assembly" means the National Assembly for Wales); in relation to  
England, Scotland and Northern Ireland it means the Secretary of  
State. See section 121(1) of the definition of "regulations".
