Mae'r Rheoliadau hyn yn diwygio Rheoliadau Llywodraethu Ysgolion (Cylch Gwaith) (Cymru) 2000, sy'n nodi nifer o egwyddorion sydd i weithredu fel cylch gwaith ar gyfer cyrff llywodraethu ac sydd hefyd yn darparu ar gyfer rôlau a chyfrifoldebau priodol cyrff llywodraethu a phenaethiaid ysgolion.

These Regulations amend the School Government (Terms of Reference) (Wales) Regulations 2000, which lay down a number of principles which are to serve as terms of reference for governing bodies and also provide for the respective roles and responsibilities of governing bodies and head teachers.

Mae'r diwygiadau'n gosod dyletswyddau penodol ar gorff llywodraethu ac ar bennaeth mewn perthynas â sefydlu polisi rheoli perfformiad ar gyfer yr ysgol. Dogfen bolisi ar gyfer yr ysgol yw hon, sy'n nodi sut y caiff y gwaith o werthuso athrawon yn yr ysgol ei gyflawni. Mae'n cydategu'r fframwaith statudol ar gyfer gwerthuso athrawon ysgol.

The amendments confer particular duties on a governing body and head teacher in respect of the establishment of a performance management policy for a school. This is a policy document for a school which sets out how school teacher appraisal at the school is to be implemented. It complements the statutory framework for the appraisal of school teachers.

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 38(3) a 138(7) ac (8) o Ddeddf Safonau a Fframwaith Ysgolion 1998(a) ac sydd bellach wedi'u breinio yng Nghynulliad Cenedlaethol Cymru(b).

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred on the Secretary of State by sections 38(3) and 138(7) and (8) of the School Standards and Framework Act 1998(a) and now vested in the National Assembly for Wales(b).

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Llywodraethu Ysgolion (Cylch Gwaith) (Diwygio) (Cymru) 2002 a deuant i rym ar 30 Medi 2002.

1. -(1) These Regulations may be cited as the School Government (Terms of Reference) (Amendment) (Wales) Regulations 2002 and shall come into force on 30th September 2002.

(2) Mae'r Rheoliadau hyn yn gymwys mewn perthynas â Chymru yn unig.

(2) These Regulations apply only in relation to Wales.

2.-(1) Mae Rheoliadau Llywodraethu Ysgolion (Cylch Gwaith) (Cymru) 2000(c) yn cael eu diwygio fel a ganlyn.

2.-(1) The School Government (Terms of Reference) (Wales) Regulations 2000(c) are amended as follows.

(2) Yn rheoliad 2(1) cyn y diffiniad o "blwyddyn ysgol" mewnosodwch y canlynol -

(2) In regulation 2(1) before the definition of "school year" insert the following -

ystyr "athro ysgol" ("*school teacher*") yw athro neu athrawes a gyflogir mewn dim mwy na dwy ysgol, gan awdurdod addysg lleol neu gan gorff llywodraethu ysgol sefydledig, ysgol wirfoddol a gynorthwyir neu ysgol arbennig sefydledig, ond nid yw'n cynnwys athro neu athrawes a gyflogir o dan gontract cyfnod penodol os yw'r cyfnod yn llai na blwyddyn;"

" "school teacher" ("*athro ysgol*") means a teacher employed at no more than two schools, by a local education authority or by the governing body of a foundation, voluntary aided or foundation special school, but does not include a teacher employed under a fixed term contract of employment the term of which is less than one year;"

(3) Ar ôl rheoliad 9 mewnosodir y rheoliad canlynol-

(3) After regulation 9 there shall be inserted the following regulation-

"Y Polisi Rheoli Perfformiad"

10.-(1) Erbyn 30 Tachwedd 2002, rhaid i'r corff llywodraethu sefydlu polisi ysgrifenedig ("y Polisi Rheoli Perfformiad") yn nodi sut mae gwerthuso athrawon ysgol i gael ei roi ar waith yn yr ysgol.

(2) Yn y rheoliad hwn, ystyr "gwerthuso athrawon ysgol" yw'r system o werthuso penaethiaid ac athrawon ysgol eraill a lywodraethir gan reoliadau a wneir o dan adran 49 o Ddeddf Addysg (Rhif 2) 1986(a) ("y Rheoliadau Gwerthuso").

(3) Os caiff ei gyfarwyddo gan y corff llywodraethu, rhaid i'r pennaeth lunio Polisi Rheoli Perfformiad.

(4) Rhaid i'r corff llywodraethu ystyried a mabwysiadu, gydag addasiadau neu hebddynt, neu wrthod, Polisi Rheoli Perfformiad a lunnir gan y pennaeth yn unol â pharagraff (3).

(5) Rhaid i'r corff llywodraethu adolygu'r Polisi Rheoli Perfformiad bob blwyddyn ysgol.

(6) Yn dilyn adolygiad o'r fath, os gwelant yn dda, bydd y corff llywodraethu'n diwygio'r Polisi Rheoli Perfformiad.

(7) Cyn sefydlu'r Polisi Rheoli Perfformiad yn unol â pharagraff (1), neu ei ddiwygio yn unol â pharagraff (6), rhaid i'r corff llywodraethu sicrhau yr ymgynghorir â phob athro ysgol yn yr ysgol.

(8) Os caiff ei gyfarwyddo gan y corff llywodraethu, rhaid i'r pennaeth ymgynghori â phob athro ysgol arall yn yr ysgol ynghylch llunio Polisi Rheoli Perfformiad neu ddiwygio Polisi Rheoli Perfformiad.

(9) Rhaid i'r pennaeth a'r corff llywodraethu roi'r Polisi Rheoli Perfformiad ar waith.

(10) Rhaid i'r corff llywodraethu drefnu bod copi o'r Polisi Rheoli Perfformiad ar gael i'w archwilio yn yr ysgol ar unrhyw adeg resymol -

- (a) gan unrhyw athro ysgol a gyflogir yn yr ysgol;
- (b) gan unrhyw berson sy'n ymwneud ag arolygu gweithredu'r system gwerthuso athrawon ysgol;

"The Performance Management Policy"

10.-(1) The governing body shall, no later than 30th November 2002 establish a written policy ("the Performance Management Policy") setting out how school teacher appraisal at the school is to be implemented.

(2) In this regulation "school teacher appraisal" means the system of appraisal of head teachers and other school teachers governed by regulations made under section 49 of the Education (No.2) Act 1986(a) ("the Appraisal Regulations").

(3) If directed to do so by the governing body, the head teacher shall formulate a Performance Management Policy.

(4) The governing body shall consider and adopt, with or without modifications, or reject, a Performance Management Policy formulated by the head teacher in pursuance of paragraph (3).

(5) The governing body shall review the Performance Management Policy every school year.

(6) Following such review, the governing body shall, if they see fit, amend the Performance Management Policy.

(7) Before establishing the Performance Management Policy in accordance with paragraph (1), or amending it in accordance with paragraph (6), the governing body shall secure that all school teachers at the school are consulted.

(8) If directed to do so by the governing body, the head teacher shall consult all other school teachers at the school about the formulation of a Performance Management Policy or the amendment of the Performance Management Policy.

(9) The head teacher and the governing body shall implement the Performance Management Policy.

(10) The governing body shall make a copy of the Performance Management Policy available for inspection at the school at any reasonable time by-

- (a) any school teacher employed at the school;
- (b) any person involved in the inspection of the operation of the school teacher appraisal system;
