**EXPLANATORY NOTE**

*(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)*

*(This note is not part of the Regulations)*

Mae'r Rheoliadau hyn yn gosod dyletswydd ar yr awdurdodau addysg lleol i gyhoeddi gwybodaeth am faterion sy'n ymwneud â darparu addysg ar gyfer plant ag anghenion addysgol arbennig.

These Regulations place a duty on local education authorities to publish information about matters relating to the provision of education for children with special educational needs.

Yn benodol, mae'n ofynnol iddynt gyhoeddi esboniad ar y rhan honno o'r ddarpariaeth addysgol arbennig y maent yn disgwyl i'r ysgolion a gynhelir ei hariannu o'u cyfran hwy o'r gyllideb, ac ar yr elfen honno y maent yn disgwyl ei hariannu eu hunain.

In particular they are required to publish an explanation of that part of special educational provision that they expect maintained schools to fund from their budget shares, and that element that they expect to fund themselves.

Hefyd rhaid iddynt gyhoeddi gwybodaeth am nodau bras eu polisi ar anghenion addysgol arbennig, yn ogystal â'r camau penodol y maent yn eu cymryd ar faterion anghenion addysgol arbennig.

They must also publish information about the broad aims of their policy on special educational needs, as well as specific action they are taking on special educational needs issues.

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 29(5), a 569(4) a (5) o Ddeddf Addysg 1996(a), ac sydd bellach wedi'u breinio yng Nghynulliad Cenedlaethol Cymru(b) drwy hyn yn gwneud y Rheoliadau canlynol:

The National Assembly for Wales, in exercise of the powers conferred on the Secretary of State by sections 29(5) and 569(4) and (5) of the Education Act 1996(a), and now vested in the National Assembly for Wales(b) hereby makes the following Regulations:

**Enwi, cychwyn, dehongli a chymhwyso****Citation, commencement, interpretation and application**

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Anghenion Addysgol Arbennig (Darparu Gwybodaeth gan Awdurdodau Addysg Lleol) (Cymru) 2002 a deuant i rym ar 1 Ebrill 2002.

1.-(1) These Regulations are called the Special Educational Needs (Provision of Information by Local Education Authorities) (Wales) Regulations 2002 and shall come into force on 1st April 2002.

(2) Yn y Rheoliadau hyn -

(2) In these Regulations-

ystyr "awdurdod gwasanaethau cymdeithasol" ("*social services authority*") yw awdurdod lleol at ddibenion Deddf Gwasanaethau Cymdeithasol Awdurdodau Lleol 1970(c) yn gweithredu i gyflawni unrhyw swyddogaethau y cyfeirir atynt yn adran 1A o'r Ddeddf honno; mae i "awdurdod iechyd" yr un ystyr â "*health authority*" yn Neddf y Gwasanaeth Iechyd Gwladol 1977(ch); ac

"health authority" ("*awdurdod iechyd*") has the same meaning as in the National Health Service Act 1977(c);

ystyr "datganiad" ("*statement*") yw datganiad o anghenion addysgol arbennig a wneir o dan adran 324 o Ddeddf Addysg 1996.

"social services authority" ("*awdurdod gwasanaethau cymdeithasol*") means a local authority for the purposes of the Local Authority Social Services Act 1970(d) acting in the discharge of such functions as are referred to in section 1A of that Act; and

"statement" ("*datganiad*") means a statement of special educational needs made under section 324 of the Education Act 1996.

(3) Mae'r Rheoliadau hyn yn gymwys mewn perthynas â Chymru yn unig.

### **Cyhoeddi gwybodaeth**

2. Rhaid i awdurdod addysg lleol -

- (a) cyhoeddi gwybodaeth am y materion a nodir yn yr Atodlen i'r Rheoliadau hyn yn unol â rheoliad 3(1), (2) a (3);
- (b) cadw golwg ar yr wybodaeth honno; ac
- (c) os ceir newid arwyddocaol mewn unrhyw ran o'r wybodaeth honno, diwygio'r wybodaeth yn unol â hynny a chyhoeddi'r wybodaeth ddiwygiedig yn unol â rheoliad 3(4).

### **Dull cyhoeddi'r wybodaeth**

3.-(1) Rhaid i'r awdurdod addysg lleol gyhoeddi'r wybodaeth y cyfeirir ati yn rheoliad 2(a) -

- (a) drwy roi copi ysgrifenedig o'r wybodaeth i unrhyw awdurdod iechyd neu awdurdod gwasanaethau cymdeithasol y mae ganddynt fuddiant yn yr wybodaeth honno ym marn yr awdurdod addysg lleol drwy'r post, drwy gyfathrebu'n electronig neu drwy unrhyw fodd arall sydd wedi'i gytuno â'r awdurdod;
- (b) drwy drefnu bod yr wybodaeth ar gael ar unrhyw wefan y gall fod yr awdurdod yn ei chynnal ar y Rhyngwrwyd;
- (c) drwy roi copi ysgrifenedig o'r wybodaeth i'r ysgolion a gynhelir yn ardal yr awdurdod drwy'r post, drwy gyfathrebu'n electronig neu drwy unrhyw fodd arall sydd wedi'i gytuno â'r awdurdod; ac
- (ch) drwy roi copi ysgrifenedig o'r wybodaeth i unrhyw berson sy'n gwneud cais amdano drwy'r post, drwy gyfathrebu'n electronig neu drwy unrhyw fodd arall sydd wedi'i gytuno â'r awdurdod.

(2) Rhaid i'r wybodaeth am y materion a nodir ym mharagraff 1 o'r Atodlen i'r Rheoliadau hyn gael ei chyhoeddi ar 30 Ebrill 2002 neu cyn hynny.

(3) Rhaid i'r wybodaeth am y materion a nodir ym mharagraffau 2 a 3 o'r Atodlen i'r Rheoliadau hyn gael ei chyhoeddi ar 31 Gorffennaf 2002 neu cyn hynny.

(4) Rhaid i unrhyw wybodaeth sydd i'w chyhoeddi yn unol â rheoliad 2(c) gael ei chyhoeddi gan yr awdurdod addysg lleol cyn gynted ag y bo'n rhesymol ymarferol ar ôl i ddiwygiad gael ei wneud -

- (a) drwy roi'r wybodaeth ddiwygiedig i awdurdod iechyd neu awdurdod gwasanaethau cymdeithasol a gafodd wybodaeth o'r blaen

(4) Nothing in these Regulations applies in relation to-

- (a) nursery schools, or
- (b) children under compulsory school age.

### **Publication of information**

2. A local education authority shall-

- (a) publish information about the matters set out in the Schedule to these Regulations in accordance with regulation 3(1), (2) and (3);
- (b) keep that information under review; and
- (c) where there is a significant change in any of that information, revise the information accordingly and publish the revised information in accordance with regulation 3(4).

### **Manner of publication of information**

3.-(1) The local education authority shall publish the information referred to in regulation 2(a) by -

- (a) providing a written copy of the information to any health authority or social services authority which in the opinion of the local education authority has an interest in that information by post, by electronic communication or by any other means agreed with the authority;
- (b) making the information available on any website which the authority may maintain on the Internet;
- (c) providing a written copy of the information to the maintained schools in the authority's area by post, by electronic communication or by any other means agreed with the authority; and
- (d) providing a written copy of the information to any person on request by post, by electronic communication or by any other means agreed with the authority.

(2) The information about the matters set out in paragraph 1 of the Schedule to these Regulations shall be published on or before 30th April 2002.

(3) The information about the matters set out in paragraphs 2 and 3 of the Schedule to these Regulations shall be published on or before 31st July 2002.

(4) Any information to be published pursuant to regulation 2(c) shall be published by the local education authority as soon as reasonably practicable after a revision has been made, by -

- (a) providing the revised information to a health authority or social services authority previously provided with information by the

(5) Rhaid i'r wybodaeth a gyhoeddir yn unol â'r rheoliad hwn gael ei chyhoeddi yn ddi-dâl.

- (b) updating any website maintained by the authority on the Internet to display the revised information;
- (c) notifying the maintained schools in the authority's area of the revisions by post, by electronic communication or by any other means agreed with the authority; and
- (d) providing the revised information to any person on request by post, by electronic communication or by any other means agreed with the authority.

(5) Information published in accordance with this regulation shall be published free of charge.

YR WYBODAETH SYDD I'W DARPARU GAN

EDUCATION AUTHORITIES

1. Esboniad ar yr elfen honno o'r ddarpariaeth addysgol arbennig ar gyfer plant ag anghenion addysgol arbennig (ond sydd heb ddatganiadau) y mae'r awdurdod addysg lleol yn disgwyl fel rheol iddi gael ei thalu o gyfran yr ysgolion a gynhelir o'r gyllideb ac ar yr elfen honno o'r ddarpariaeth honno y mae'r awdurdod yn disgwyl fel rheol iddi gael ei thalu gan yr awdurdod o'r arian sydd ganddo yn ganolog.

2. Nodau bras polisi'r awdurdod addysg lleol mewn perthynas â phlant ag anghenion addysgol arbennig ynghyd â gwybodaeth am y camau y mae'r awdurdod yn eu cymryd -

- (a) i hybu safonau addysgol uchel i blant ag anghenion addysgol arbennig;
- (b) i annog plant ag anghenion addysgol arbennig i chwarae rhan gyflawn yn eu hysgol a'u cymuned ac i gymryd rhan mewn penderfyniadau am eu haddysg ac i wneud dewisiadau amdani;
- (c) i annog yr ysgolion yn eu hardal i rannu eu harferion wrth wneud darpariaeth addysgol arbennig ar gyfer plant ag anghenion addysgol arbennig; ac
- (ch) i weithio gyda chyrff statudol a gwirfoddol eraill i ddarparu cymorth i blant ag anghenion addysgol arbennig.

3. Y trefniadau cyffredinol a wneir gan yr awdurdod addysg lleol, gan gynnwys unrhyw gynlluniau, amcanion a graddfeydd amser ar gyfer -

- (a) adnabod plant yn eu hardal sydd ag anghenion addysgol arbennig;
- (b) monitro derbyniadau plant ag anghenion addysgol arbennig (p'un a oes gan y plant hyn ddatganiad neu beidio) i'r ysgolion a gynhelir yn eu hardal;
- (c) trefnu asesiadau anghenion addysgol plant yn unol ag adran 323 o Ddeddf Addysg 1996 yn ardal yr awdurdod addysg lleol, gan gynnwys unrhyw brotocolau lleol ar gyfer gwneud hyn;
- (ch) trefnu gwneud a chynnal datganiadau yn eu hardal gan gynnwys unrhyw brotocolau lleol ar gyfer gwneud hyn;
- (d) rhoi cymorth i'r ysgolion yn eu hardal mewn perthynas â gwneud darpariaeth addysgol arbennig ar gyfer plant ag anghenion addysgol arbennig;
- (dd) archwilio, cynllunio, monitro ac adolygu'r ddarpariaeth ar gyfer plant ag anghenion addysgol arbennig yn eu hardal, yn gyffredinol

1. An explanation of that element of special educational provision for children with special educational needs (but without statements) which the local education authority expect normally to be met from maintained schools' budget shares and that element of such provision that the authority expect normally to be met by the authority from funds which it holds centrally.

2. The broad aims of the local education authority's policy in respect of children with special educational needs together with information about the action the authority is taking to-

- (a) promote high standards of education for children with special educational needs;
- (b) encourage children with special educational needs to participate fully in their school and community and to take part in decisions and make choices about their education;
- (c) encourage schools in their area to share their practice in making special educational provision for children with special educational needs; and
- (d) work with other statutory and voluntary bodies to provide support for children with special educational needs.

3. The general arrangements made by the local education authority, including any plans, objectives and timescales, for-

- (a) identifying children in their area with special educational needs;
- (b) monitoring the admission of children with special educational needs (whether or not those children have a statement) to maintained schools in their area;
- (c) organising the assessment of children's educational needs pursuant to section 323 of the Education Act 1996 in the local education authority's area including any local protocols for so doing;
- (d) organising the making and maintaining of statements in their area including any local protocols for so doing;
- (e) providing support to schools in their area with regard to making special educational provision for children with special educational needs;
- (f) auditing, planning, monitoring and reviewing provision for children with special educational needs in their area, both generally and in
