Mae'r Rheoliadau hyn yn diwygiong Rheoliadau Addysg (Cymwysterau a Safonau Iechyd Athrawon) (Cymru) 1999 ("Rheoliadau 1999") er mwyn galluogi statws athro cymwysedig i gael ei ddyfarnu i athrawon penodol mewn ysgolion annibynnol neu athrawon addysg bellach penodol sy'n cael eu cyflogi mewn sefydliadau addysg bellach neu fel hyfforddwyr mewn ysgolion.

O dan y Rheoliadau diwygiedig, caniateir yn awr i athro gael ei gymeradwyo i gael statws athro cymwysedig os yw'n cael ei gyflogi ar hyn o bryd fel athro mewn ysgol annibynnol, os yw wedi'i asesu fel un sy'n bodloni'r safonau ar gyfer statws athro cymwysedig ac yn dal un o'r cymwysterau a bennir yn y Rheoliadau, ar yr amod ei fod wedi'i gyflogi fel athro mewn ysgol annibynnol cyn 1 Medi 1989. Yn fras, y cymwysterau penodedig yw graddau a chymwysterau eraill a gymeradwywyd gan yr Ysgrifennydd Gwladol at ddibenion dyfarnu statws athro cymwysedig a gafwyd cyn 1 Ionawr 1974 a graddau a gymeradwywyd gan yr Ysgrifennydd Gwladol at ddibenion dyfarnu statws athro cymwysedig a gafwyd cyn 1 Medi 1989. Gellir dyfarnu statws athro cymwysedig i athrawon o'r fath yn unol ag argymhelliaid penneth neu benadur ysgol annibynnol lle maent yn cael eu cyflogi, neu yn achos penneth neu benadur ysgol annibynnol, yn unol ag argymhelliaid cadeirydd corff llywodraethu'r ysgol, neu os nad oes un, perchenog yr ysgol - gweler rheoliadau 5 a 6 (sy'n mewnosod paragraffau 10 a 12-19 newydd yn Atodlen 3 i Reoliadau 1999).

The Education (Teachers' Qualifications and Health Standards) (Wales) (Amendment) Regulations 2002

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Education (Teachers' Qualifications and Health Standards) (Wales) Regulations 1999 ("the 1999 Regulations") to enable certain teachers in independent schools or certain further education teachers employed at further education institutions or as instructors at schools, to be awarded qualified teacher status.

Under the amended Regulations, a teacher may now be recommended for qualified teacher status if he or she is currently employed as a teacher in an independent school, has been assessed as meeting the standards for qualified teacher status and holds one of the qualifications specified in the Regulations, provided he or she was employed as a teacher at an independent school before 1st September 1989. Broadly, the specified qualifications are degrees and other qualifications approved by the Secretary of State for the purpose of the award of qualified teacher status and obtained before 1st January 1974 and degrees approved by the Secretary of State for the purpose of the award of qualified teacher status and obtained before 1st September 1989. Qualified teacher status may be awarded to such teachers on the recommendation of the head teacher or principal of the independent school at which they are employed, or in the case of the head teacher or principal of an independent school, on the recommendation of the chairman of the school's governing body, or if none the school's proprietor - see regulations 5 and 6 (which insert new paragraphs 10 and 12-19 in Schedule 3 to the 1999 Regulations).

O dan y Rheoliadau diwygiedig caniateir yn awr i athrawon addysg bellach gael eu cymeradwyo i gael statws athro cymwysedig os yw amodau penodol yn cael eu bodloni. Yr amodau hynny yw bod yr athro yn cael ei gyflogi fel athro mewn sefydliad addysg bellach neu fel hyfforddwr mewn ysgol, ei fod wedi'i asesu fel un sy'n bodloni'r safonau penodedig, ei fod yn dal un o'r cymwysterau a bennir yn Rhan II o Atodlen 3 neu radd, ei fod wedi'i gyflogi fel athro mewn sefydliad addysg bellach cyn 1 Medi 1989, ei fod yn dal Tystysgrif mewn Addysg neu Dystysgrif Addysg i Raddedigion, a bod ganddo ddigon o brofiad addysgu ym marn y corff argymhell i allu addysgu disgyblion 14-19 oed - gweler rheoliadau 5 a 6 (sy'n mewnosod paragraffau 11 a 12-19 newydd yn Atodlen 3 i Reoliadau 1999).

Under the amended Regulations further education teachers may now be recommended for qualified teacher status if certain conditions are satisfied. Those conditions are that the teacher is employed as a teacher in a further education institution or as an instructor in a school, has been assessed as meeting the specified standards, holds one of the qualifications specified in Part II of Schedule 3 or a degree, was employed as a teacher at a further education institution before 1st September 1989, holds a Certificate in Education or a Post-Graduate Certificate in Education, and in the opinion of the recommending body has sufficient teaching experience to be able to teach pupils aged 14-19 years - see regulations 5 and 6 (inserting new paragraphs 11 and 12-19 in Schedule 3 to the 1999 Regulations).

3. Yn rheoliad 3(2) yn y man priodol yn nhrefn yr wyddor mewnosodir y diffiniad canlynol:

"mae i "corff llywodraethu" mewn perthynas â sefydliad addysg bellach yr un ystyr â "governing body" yn adran 90(1) o Ddeddf Addysg Bellach ac Uwch 1992(ch);".

The Education (Teachers' Qualifications and Health Standards) (Wales) (Amendment) Regulations 2002

Made

27th November 2002

Coming into force

17th December 2002

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred on the Secretary of State by sections 218(1)(a) and (2) and 232(5) and (6) of the Education Reform Act 1988(a) and now vested in the National Assembly(b).

Name and commencement

1. These Regulations are called the Education (Teachers' Qualifications and Health Standards) (Wales) (Amendment) Regulations 2002 and shall come into force on 17th December 2002.

Amendment of Regulations

2. The Education (Teachers' Qualifications and Health Standards) (Wales) Regulations 1999(c) shall be amended as follows.

3. In regulation 3(2) at the appropriate point in alphabetical order there shall be inserted the following definition:

"governing body" ("*corff llywodraethu*") in relation to a further education institution has the same meaning as in section 90(1) of the Further and Higher Education Act 1992(d);".

4. Schedule 3 shall become Part I of Schedule 3, and immediately before paragraph 1 there shall be inserted the heading "PART I".

 - (iii) before 1st September 1989 he or she obtained a degree granted by a United Kingdom university or by the Council for National Academic Awards or by a foreign institution in mathematics, physics, chemistry, biology, botany, zoology, physiology, biochemistry or geology; and
- (d) he or she was employed as a teacher in an independent school before 1st September 1989.
