EXPLANATORY NOTE

Mae'r Rheoliadau hyn, sy'n gymwys i Gymru, yn diwygio Rheoliadau'r Gronfa Ddata Gwartheg 1998 (O.S. 1998/1796) i'r graddau y maent yn ymwneud â'r cyfnod y mae'n rhaid i geidwad roi hysbysiad i Gynulliad Cenedlaethol Cymru am symudiad gwartheg.

These Regulations, which apply to Wales, amend the Cattle Database Regulations 1998 (S.I. 1998/1796) as far as they concern the period within which a keeper must give notification to the National Assembly for Wales of the movement of cattle.

Effaith y diwygiad sy'n cael ei wneud gan y Rheoliadau yw lleihau'r cyfnod y mae'n rhaid hysbysu'r Cynulliad Cenedlaethol ynddo drwy'r post neu drwy ddull electronig am symudiad anifeiliaid o saith diwrnod i dri (rheoliad 2). Mae hyn yn unol â gofynion ail indent Erthygl 7.1 o Reoliad (EC) Rhif 1760/2000 sy'n sefydlu system ar gyfer adnabod a chofrestru anifeiliaid buchol (OJ Rhif L204, 11.8.2000, t. 1).

The effect of the amendment made by the Regulations is to reduce the period within which notification of movements of cattle must be posted or made by electronic means to the National Assembly from seven to three days (regulation 2). This is in accordance with the requirements of the second indent of Article 7.1 of Regulation (EC) No. 1760/2000 establishing a system for the identification and registration of bovine animals (OJ No. L204, 11.8.2000, p. 1).

Mae Cynulliad Cenedlaethol Cymru, gan ei fod wedi'i ddynodi(a) at ddibenion adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972(b) mewn perthynas â pholisi amaethyddiaeth cyffredin y Gymuned Ewropeaidd, drwy arfer y pwerau a roddwyd iddo gan yr adran honno, a phob pŵer arall sy'n ei alluogi yn y cyswllt hwnnw, yn gwneud y Rheoliadau canlynol:

The National Assembly for Wales, being designated(a) for the purposes of section 2(2) of the European Communities Act 1972(b) in relation to the common agricultural policy of the European Community, in exercise of the powers conferred on it by that section, and of all other powers enabling it in that behalf, makes the following Regulations:

1. Enw'r Rheoliadau hyn yw Rheoliadau'r Gronfa Ddata Gwartheg (Diwygio) (Cymru) 2002; maent yn gymwys i Gymru a deuant i rym ar 11 Chwefror 2002.

Title, application and commencement

1. These Regulations are called the Cattle Database (Amendment) (Wales) Regulations 2002; they apply to Wales and come into force on 11th February 2002.
