EXPLANATORY NOTE

O dan Ran II o Atodlen 8 i Ddeddf Cyllid Llywodraeth Leol 1988 mae'n ofynnol i awdurdodau bilio yng Nghymru dalu symiau (a elwir yn gyfraniadau ardrethu annomestig) i Gynulliad Cenedlaethol Cymru. Mae'r rheolau ar gyfer cyfrifo'r symiau hynny wedi'u cynnwys yn Rheoliadau Cyfraniadau Ardrethu Annomestig (Cymru) 1992.

Under Part II of Schedule 8 to the Local Government Finance Act 1988 billing authorities in Wales are required to pay amounts (called non-domestic rating contributions) to the National Assembly for Wales. Rules for the calculation of those amounts are contained in the Non-Domestic Rating Contributions (Wales) Regulations 1992.

Mae'r Rheoliadau hyn yn diwygio Rheoliadau 1992 drwy roi lluosydd newydd ym mharagraff 2(12) o Atodlen 2 (rhagdybiaethau ynglŷn â'r swm gros), ac Atodlen 4 newydd (ffigurau poblogaeth oedolion).

These Regulations amend the 1992 Regulations by substituting a new multiplier in paragraph 2(12) of Schedule 2 (assumptions as to gross amount) and a new Schedule 4 (adult population figures).

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 140(4) a 143(1) a (2) o Ddeddf Cyllid Llywodraeth Leol 1988(a) a pharagraffau 4, 5 a 6 o Atodlen 8 iddi, sydd wedi'u breinio bellach yng Nghynulliad Cenedlaethol Cymru i'r graddau y maent yn arferadwy yng Nghymru(b):

The National Assembly for Wales makes the following Regulations in exercise of the powers given to the Secretary of State by sections 140(4) and 143(1) and (2) of, and paragraphs 4, 5 and 6 of Schedule 8 to, the Local Government Finance Act 1988(a), which are now vested in the National Assembly for Wales so far as exercisable in Wales(b):

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Cyfraniadau Ardrethu Annommestig (Cymru) (Diwygio) 2002 a deuant i rym ar 31 Rhagfyr 2002.

(2) Yn y Rheoliadau hyn ystyr "Rheoliadau 1992" yw Rheoliadau Cyfraniadau Ardrethu Annommestig (Cymru) 1992(c).

Name, commencement and interpretation

1.-(1) These Regulations may be cited as the Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 2002 and shall come into force on 31st December 2002.

(2) In these Regulations "the 1992 Regulations" means the Non-Domestic Rating Contributions (Wales) Regulations 1992(c).

Diwygio Rheoliadau 1992

2. Ynglŷn â'r blynyddoedd ariannol sy'n dechrau ar neu ar ôl 1 Ebrill 2003, diwygir Atodlenni 2 a 4 i Rheoliadau 1992 fel a ganlyn: -

- (a) ym mharagraff 2(12) o Atodlen 2 yn lle "0.995" rhoddir "0.999"; a
- (b) yn lle Atodlen 4 i Rheoliadau 1992 rhoddir yr Atodlen a nodir yn yr Atodlen i'r Rheoliadau hyn.

Amendment of the 1992 Regulations

2. In relation to financial years beginning on or after 1st April 2003, Schedules 2 and 4 to the 1992 Regulations are amended as follows: -

- (a) in paragraph 2(12) of Schedule 2 for "0.995" there is substituted "0.999"; and
- (b) for Schedule 4 to the 1992 Regulations there is substituted the Schedule set out in the Schedule to these Regulations.

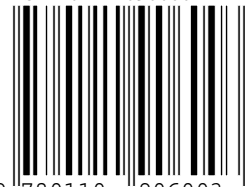
