- (b) rhoi awdurdod dros dro ar gyfer marchnata a defnyddio sucralose fel melysydd, fel a ganiateir gan Erthygl 5 o Gyfarwyddeb 89/107/EEC ar gyd-ddyngesiad cyfreithiau'r Aelod-wladwriaethau sy'n ymwneud ag ychwanegion bwyd a awdurdodir i'w defnyddio mewn bwydydd a fwriadwyd ar gyfer eu bwyta gan bobl (OJ Rhif L40, 11.2.1989, t.27) (rheoliadau 2(2)(b) a 2(3); ac
- (c) diweddarur cyfeiriadau at Reoliadau 1995 mewn Rheoliadau eraill.

#### The Sweeteners in Food (Amendment) (Wales) Regulations 2002

#### EXPLANATORY NOTE

(*This note is not part of the Regulations*)

These Regulations, which extend to Wales only, further amend the Sweeteners in Food Regulations 1995 (S.I. 1995/3123 as already amended) which extend to Great Britain, by -

- (a) bringing up to date the definition of "Directive 95/31/EC" (which relates to specific purity criteria) so as to cover its amendment by Directive 2001/52/EC (OJ No. L190, 12.7.2001, p.18) to substitute new purity criteria for mannitol and acesulfame K (regulation 2(2)(a));
- (b) granting provisional authorisation for the marketing and use as a sweetener of sucralose, as permitted by Article 5 of Directive 89/107/EEC on the approximation of the laws of the member States concerning food additives authorised for use in foodstuffs intended for human consumption (OJ No. L40, 11.2.1989, p.27) (regulations 2(2)(b) and 2(3); and
- (c) bringing up to date references to the 1995 Regulations in other Regulations.

(2) Yn y Rheoliadau hyn ystyr "y prif Reoliadau" ("the principal Regulations") yw Rheoliadau Melysyddion mewn Bwyd 1995(c).

**Diwygio'r prif Reoliadau**

2. -(1) Caiff y prif Reoliadau eu diwygio, i'r graddau y maent yn gymwys i Gymru, yn unol â pharagraffau (2) a (3) isod.

2002***Made**13th February 2002**Coming into force**1st March 2002*

In exercise of the powers conferred by sections 16(1)(a) and (e), 17(1), 26(1) and (3) and 48(1) of, and paragraph 1 of Schedule 1 to, the Food Safety Act 1990(a), and now vested in the National Assembly for Wales(b), the National Assembly for Wales, having had regard, in accordance with section 48(4A) of that Act, to relevant advice given by the Food Standards Agency and after consultation in accordance with section 48(4) and (4B) of that Act, makes the following Regulations:

**Citation, commencement, extent and interpretation**

1.-(1) These Regulations may be cited as the Sweeteners in Food (Amendment) (Wales) Regulations 2002, shall come into force on 1st March 2002 and shall extend to Wales only.

(2) In these Regulations "the principal Regulations" ("y prif Reoliadau") means the Sweeteners in Food Regulations 1995(c).

**Amendment of the principal Regulations**

2.-(1) The principal Regulations shall be amended, insofar as they extend to Wales, in accordance with paragraphs (2) and (3) below.

(2) In paragraph (1) of regulation 2(interpretation) -

(a) in the definition of "Directive 95/31/EC" there shall be added at the end the words "and by

## Diwygiadau canlyniadol

**3.-(1)** Bydd paragraff (2) o reoliad 4 (diwygiadau canlyniadol) o Reoliadau Melysyddion mewn Bwyd (Diwygio) (Cymru) 2001(**b**) yn peidio â bod yn effeithiol.

(2) Yn y darpariaethau a bennir ym mharagraff (3) isod, i'r graddau y maent yn gymwys i Gymru, rhaid dehongli cyfeiriadau at y prif Reoliadau fel cyfeiriadau at y Rheoliadau hynny fel y'u diwygiwyd hyd at a chan gynnwys y diwygiadau a weithredir gan y Rheoliadau hyn.

(3) Dyma'r darpariaethau y mae paraagraff (2) uchod yn cyfeirio atynt -

- (a) y diffiniad o "permitted sweetener" ym mharagraff (1) o reoliad 2 (interpretation) o Reoliadau Jam a Chynnyrch Tebyg 1981(**c**);
- (b) y diffiniad o "additive" ym mharagraff (1) o reoliad 2 (dehongli) o Reoliadau Cynhyrchion Cig a Chynhyrchion Pysgod y gellir eu Taenu 1984(**ch**);
- (c) y diffiniad o "sweetener" yn Rhan II o Atodlen 1 (categorïau o ychwanegion bwyd) i

Directive 2001/52/EC"(**a**); and

- (b) for the definition of "permitted sweetener" there shall be substituted the following definition -

""permitted sweetener" means any sweetener specified in column 2 of Schedule 1 which satisfies the specific purity criteria for that sweetener set out -

- (a) in the case of any sweetener other than sucralose, in the Annex to Directive 95/31/EC; and
- (b) in the case of sucralose, at pages 119 to 124 of the Food and Agriculture Organisation's Compendium of Food Additives Specifications Addendum 2 (1993) FAO Food and Nutrition Paper 52 Addendum 2;".

(3) In Schedule 1 (permitted sweeteners and the foods in or on which they may be used) there shall be added at the end, in columns 2 to 4, the provisions specified in the Schedule to these Regulations.

## Consequential amendments

**3.-(1)** Paragraph (2) of regulation 4 (consequential amendments) of the Sweeteners in Food (Amendment) (Wales) Regulations 2001(**b**) shall cease to have effect.

(2) In the provisions specified in paragraph (3) below, insofar as they extend to Wales, references to the principal Regulations shall be construed as references to those Regulations as amended up to and including the amendments effected by these Regulations.

(3) The provisions to which paragraph (2) above refers are -

- (a) the definition of "permitted sweetener" in paragraph (1) of regulation 2 (interpretation) of the Jam and Similar Products Regulations 1981(**c**);
- (b) the definition of "additive" in paragraph (1) of regulation 2 (interpretation) of the Meat Products and Spreadable Fish Products Regulations 1984(**d**);
- (c) the definition of "sweetener" in Part II of Schedule 1 (categories of food additives) to the
