Mae'r Rheoliadau hyn yn diwygio ymhellach Rheoliadau'r Gwasanaeth Iechyd Gwladol (Gwasanaethau Meddygol Cyffredinol) 1992 ("y Rheoliadau Gwasanaethau Meddygol Cyffredinol"), sy'n rheoleiddio'r telerau y mae meddygon yn darparu gwasanaethau meddygol cyffredinol odanynt yn ôl Deddf Gwasanaeth Iechyd Gwladol 1977 ("Deddf 1977") a Rheoliadau'r Gwasanaeth Iechyd Gwladol (Gwasanaethau Fferyllol) 1992 ("y Rheoliadau Gwasanaethau Fferyllol"), sydd yn rheoli'r ddarpariaeth o wasanaethau fferyllol o dan Ddeddf 1977.

Mae rheoliad 2 yn diwygio paragraff 43 o Atodlen 2 i'r Rheoliadau Gwasanaethau Meddygol Cyffredinol (Telerau Gwasanaeth i Feddygon) i ganiatáu meddygon i ragnodi fesul dyraniad y cyffuriau hynny a restrir yn Atodlenni 2 hyd 5 o Reoliadau Camddefnyddio Cyffuriau 2001 ar gyfer trin y cyflwr o fod yn gaeth i unrhyw un o'r cyffuriau a restrir yn yr Atodlenni hynny. Yr oedd Rheoliadau Camddefnyddio Cyffuriau 2001 yn dirymu Rheoliadau Camddefnyddio Cyffuriau 1985 a'u hailddeddfu gyda diwygiadau.

Y mae hefyd yn cywiro rhywbeth a hepgorwyd o is-baragraffau 43(5) a (6).

EXPLANATORY NOTE

(*This note is not part of the Regulations*)

These Regulations further amend the National Health Service (General Medical Services) Regulations 1992 ("the General Medical Services Regulations"), which regulate the terms on which doctors provide general medical services under the National Health Service Act 1977 ("the 1977 Act") and the National Health Service (Pharmaceutical Services) Regulations 1992 ("the Pharmaceutical Services Regulations"), which govern the provision of pharmaceutical services under the 1977 Act.

Regulation 2 amends paragraph 43 of Schedule 2 to the General Medical Services Regulations (Terms of Service for Doctors) to allow doctors to prescribe by instalments those drugs listed in Schedules 2 to 5 of the Misuse of Drugs Regulations 2001, for the treatment of drug addiction to any of the drugs listed in those Schedules. The Misuse of Drugs Regulations 2001 revoked and re-enacted with amendments the Misuse of Drugs Regulations 1985.

It also corrects an omission in sub-paragraphs 43(5) and (6).

Regulation 3 makes amendments to Schedule 2 to the Pharmaceutical Services Regulations (Terms of Service for Chemists) that are consequential to coming into force of the Misuse of Drugs Regulations 2001.

The National Assembly for Wales, in exercise of the
powers conferred upon it by sections 29, 41, 42, 43 and
126(4) of the National Health Service Act 1977 (a)
hereby makes the following Regulations:

(a) 1977 c.49; see section 128(1) as amended by the National Health
Service and Community Care Act 1990 (c.19) ("the 1990 Act"),
section 26(2)(g) and (i), and by the Health Act 1999 (c.8) ("the 1999
Act"), Schedule 4, paragraph 38(2)(b), for the definitions of
"prescribed" and "regulations".

Citation, commencement, interpretation and application

1.-(1) These Regulations may be cited as the National Health Service (General Medical Services) and (Pharmaceutical Services) (Amendment) (Wales) Regulations 2003 and shall come into force on 1st February 2003.

(2) In these Regulations-

"the General Medical Services Regulations" means the National Health Service (General Medical Services) Regulations 1992(a);

"the Pharmaceutical Services Regulations" means the National Health Service (Pharmaceutical Services) Regulations 1992(b).

(3) These Regulations apply to Wales only.

Amendment of the Schedule 2 to the General Medical Services Regulations

2.-(1) Schedule 2 to the General Medical Services Regulations (Terms of Service for Doctors) shall be amended in accordance with the following provisions of this regulation.

(2) In paragraph 43 (prescribing)-

(a) for the opening wording of sub-paragraph (3), substitute -

"(3) Where a doctor orders drugs specified in Schedules 2 to 5 to the Misuse of Drugs Regulations 2001(c) (controlled drugs to which regulations, 14, 15, 16, 18, 19, 20, 21, 22, 23, 24, 26 and 27 of those Regulations apply) for supply by instalments for treating addiction to any drug specified in those Schedules, he shall-";

(b) in sub-paragraph (5) (b), for "other than a drug which is for the time being specified in Schedule 5 to the Misuse of Drugs Regulations 1985(d); " substitute "other than a drug which is for the time being specified in Schedules 4 or 5 to the Misuse of Drugs Regulations 2001;";

(c) in sub-paragraph (6) (a), for "other than a drug which is for the time being specified in Schedule 5 to the Misuse of Drugs Regulations 1985" substitute "other than a drug which is for the time being specified in Schedules 4 or 5 to

(a) S.I.1992/635 to which there are amendments not relevant to this instrument.

(b) S.I. 1992/662; the relevant amending instrument is 1993/2451.

(c) S.I. 2001/3998, which revoked and re-enacted with amendments the provisions of the Misuse of Drugs Regulations 1985 (S.I. 1985/2066).

(d) S.I.1985/2066; which was revoked and re-enacted with amendments by S.I. 2001/3998.
