Mae'r Rheoliadau hyn yn gymwys i Gymru'n unig. Maent yn diwygio Rheoliadau Bwyd (Ffigys, Cnau Cyll a Chnau Pistasio o Dwrci) (Rheolaeth Frys) (Cymru) (Rhif 2) 2002 (O.S.2002/2296) (Cy.225) (*rheoliad 2*) O.S. 2002/2296 (Cy.225) sy'n gweithredu Penderfyniad y Comisiwn 2002/2296/EC sy'n gosod amodau arbennig ar fewnforio ffigys, cnau cyll a chnau pistasio a chynhyrchion penodol sy'n deillio ohonynt ac sy'n tarddu o Dwrci neu'n cael eu traddodi oddi yno (OJ Rhif L34, 5.2.2002, t.26) fel y'i diwygiwyd gan Benderfyniad y Comisiwn 2002/233/EC (OJ Rhif L78, 21.3.2002, t.14) a Phenderfyniad y Comisiwn 2002/679/EC (Rhif OJ L229, 27.8.2002, t. 37).

These Regulations, which apply in relation to Wales only, amend the Food (Figs, Hazelnuts and Pistachios from Turkey) (Emergency Control) (Wales) (No. 2) Regulations 2002 (S.I. 2002/2296) (W.225) (*regulation 2*). S.I. 2002/2296 (W.225) implements Commission Decision 2002/80/EC imposing special conditions on the import of figs, hazelnuts and pistachios and certain products derived thereof originating in or consigned from Turkey (OJ No. L34, 5.2.2002, p.26) as amended by Commission Decision 2002/233/EC (OJ No. L78, 21.3.2002, p.14) and Commission Decision 2002/679/EC (OJ No. L229, 27.8.2002, p.37).

Effaith y diwygio a wneir gan y Rheoliadau hyn yw bod O.S. 2002/2296 (Cy.225) yn awr yn gweithredu Penderfyniad y Comisiwn 2002/80/EC fel y'i diwygiwyd bellach gan Benderfyniad y Comisiwn 2003/552/EC (Rhif OJ L187, 26.7.2003, t. 47). Pennir y categorïau o gynhyrchion sydd yn ddarostyngedig i'r amodau mewnforio arbennig y cyfeirir atynt uchod yn Erthygl 1 o Benderfyniad y Comisiwn 1/2002/EC fel y'i diwygiwyd gan Benderfyniad y Comisiwn 2003/552/EC.

The effect of the amendment made by these Regulations is that S.I. 2002/2296 (W.225) now implements Commission Decision 2002/80/EC as now also amended by Commission Decision 2003/552/EC (OJ No. L187, 26.7.2003, p.47). The categories of products which are subject to the special import conditions referred to above are specified in Article 1(1) of Commission Decision 2002/80/EC as amended by Commission Decision 2002/679/EC and Commission Decision 2003/552/EC.

Dyma'r prif newidiadau sy'n cael eu hachosi gan y Rheoliadau hyn -

The principal changes effected by these Regulations are that -

- (a) mae'r diffiniad o "Penderfyniad y Comisiwn" yn rheoliad 2(1) o O.S. 2002/2296 (Cy.225) yn cael ei ddiweddarau i adlewyrchu'r diwygiad a wneir iddo gan Benderfyniad y Comisiwn 2003/552/EC;

- (a) the definition of "the Commission Decision" in regulation 2(1) of S.I. 2002/2296 (W.225) is updated to reflect the amendment made to it by Commission Decision 2003/552/EC;

- (b) mae diwygiad canlyniadol i'r diffiniad o "Turkish products" yn rheoliad 2(1) o O.S. 2002/2296 (Cy. 225); ac
- (c) addaswyd y gofyniad blaenorol bod bob llwyth o gynhyrchion Twrciaidd o dan reolaeth yn ddarostyngedig i samplu a dadansoddi er mwyn sicrhau cydymffurfedd â Phenderfyniad y Comisiwn 2002/80/EC, fel y'i diwygiwyd, drwy ddarparu -
 - (i) bod samplu a dadansoddi mewn perthynas ag aflatoxin B1 a'r cyfanswm o lefelau aflatoxin yn digwydd mewn perthynas â llwythi o ffigys sychion, cnau cyll a chnau pistasio a chynhyrchion penodol sy'n deillio ohonynt,
 - (ii) bod rhaid i'r cyfnod cadw at ddibenion hapsamplu a hapddadansoddi beidio â bod yn hwy na 15 diwrnod gwaith, a
 - (iii) bod rhaid i gopi o'r dystysgrif iechyd a'r dogfennau sy'n mynd gyda hi fynd gyda phob rhan o lwyth hollt.

Nid oes arfarniad rheoliadol wedi'i baratoi mewn cysylltiad â'r Rheoliadau hyn.

- (b) there is a consequential amendment to the definition of "Turkish Products" in regulation 2(1) of S.I. 2002/2296 (W. 225); and
- (c) the previous requirement that consignments of controlled Turkish products be subjected to random sampling and analysis to ensure compliance with Commission Decision 2002/80/EC, as amended, is modified by providing that -
 - (i) sampling and analysis in relation to aflatoxin B1 and total aflatoxin shall be undertaken in respect of consignments of dried figs, hazelnuts and pistachios and certain products derived thereof,
 - (ii) the period of detention for the purpose of random sampling and analysis must not exceed 15 working days, and
 - (iii) each part of a split consignment must be accompanied by a copy of the health certificate and accompanying documents.

No regulatory appraisal has been prepared in relation to these Regulations.

Title, commencement and application

1.-(1) These Regulations may be cited as the Food (Figs, Hazelnuts and Pistachios from Turkey) (Emergency Control) (Wales) (Amendment) Regulations 2003 and shall come into force on 6th September 2003.

(2) These Regulations apply in relation to Wales only.

2.-(1) Paragraph (1) of regulation 2 (interpretation) to the Food (Figs, Hazelnuts and Pistachios from Turkey) (Emergency Control) (Wales) (No. 2) Regulations(c) is amended in accordance with paragraphs (2) and (3).

(2) The definition of "the Commission Decision" shall be replaced by the following definition -

""the Commission Decision" means Commission Decision 2002/80/EC imposing special conditions on the import of figs, hazelnuts and pistachios and certain products derived thereof

- (c) Article 1.7 of that Decision (which is concerned with the case where consignments are split)".
