**The Condensed Milk and Dried
Milk (Wales) Regulations 2003**

EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

(This note is not part of the Regulations)

Mae'r Rheoliadau hyn yn gymwys i Gymru. Maent yn gweithredu Cyfarwyddeb y Cyngor 2001/114/ (OJ Rhif L19, 17.1.2002, t.19). Ymwneud â chynhyrchion llaeth penodol a fwriedir i'w bwyta gan bobl ac sydd naill ai'n rhannol neu'n llwyr wedi'u sychu (wedi'u dadhydradu) a'u cadw (eu preserfio) y mae'r Gyfarwyddeb honno. Mae'r Rheoliadau hyn yn dirymu ac yn disodli Rheoliadau Llaeth Cyddwys a Llaeth Sych 1977, fel y'u diwygiwyd, mewn perthynas â Chymru.

These Regulations, which apply to Wales, implement Council Directive 2001/114/EC relating to certain partly or wholly dehydrated preserved milk products intended for human consumption (OJ No. L15, 17.1.2002, p.19). They revoke and replace the Condensed Milk and Dried Milk Regulations 1977, as amended, in relation to Wales.

Mae'r Rheoliadau yn -

The Regulations -

- (a) rhagnodi diffiniadau a disgrifiadau neilltuedig ar gyfer cynhyrchion llaeth cyddwys a llaeth sych (rheoliad 2 ac Atodlenni 1 a 2);
- (b) darparu i'r Rheoliadau fod yn gymwys i gynhyrchion llaeth a llaeth sych a fwriedir i'w bwyta gan bobl ac sy'n barod i'w dosbarthu i'r defnyddiwr olaf neu i sefydliad arlwyo (rheoliad 3);
- (c) cyfyngu ar y defnydd o ddisgrifiadau neilltuedig i'r cynhyrchion llaeth cyddwys a llaeth sych y maent yn ymwneud â hwy (rheoliad 4);
- (ch) rhagnodi gofynion labelu ar gyfer cynhyrchion llaeth cyddwys a llaeth sych dynodedig (rheoliad 5);
- (d) rhagnodi dull y marcio neu labelu a chymhwyso darpariaethau penodedig Rheoliadau Labelu Bwyd 1996 (rheoliad 6);
- (dd) pennu cosb, awdurdodau gorfodi ac, yn unol ag Erthyglau 2 a 3 o Gyfarwyddeb y Cyngor

- (a) prescribe definitions and reserved descriptions for condensed milk and dried milk products (regulation 2 and Schedules 1 and 2);
- (b) provide for the Regulations to apply to milk and dried milk products intended for human consumption and ready for delivery to the ultimate consumer or to a catering establishment (regulation 3);
- (c) restrict the use of reserved descriptions to the designated condensed and dried milk products to which they relate (regulation 4);
- (d) prescribe labelling requirements for designated condensed and dried milk products (regulation 5);
- (e) prescribe the manner of marking or labelling and apply specified provisions of the Food Labelling Regulations 1996 (regulation 6);
- (f) specify a penalty, enforcement authorities and, in accordance with Articles 2 and 3 of Council

89/397/EEC ar reolaeth swyddogol bwydydd (OJ Rhif L186, 30.6.89, t.23), amddiffyniad sy'n ymwneud ag allforion (rheoliadau 7 ac 8);

- (e) cymhwyso amryw ddarpariaethau Deddf Diogelwch Bwyd 1990 (rheoliad 9);
- (f) dirymu'r Rheoliadau blaenorol a gwneud diwygiadau canlyniadol a darpariaeth drosiannol (rheoliadau 10 ac 11). Effaith y dirymiad a wneir gan reoliad 10(1)(a), ac absenoldeb ailddeddfiad o ddarpariaeth debyg, yw y bydd Rhan II o Reoliadau Labelu Bwyd 1996 yn gymwys i'r cynhyrchion y mae'r Rheoliadau hyn yn gymwys iddynt.

Cafodd arfarniad rheoliadol ei baratoi yn unol ag adran 65 o Ddeddf Llywodraeth Cymru 1998 a rhoddwyd copi yn llyfrgell Cynulliad Cenedlaethol Cymru ynghyd â Nodyn Trosi sy'n egluro sut y mae prif elfennau'r ddeddfwriaeth Ewropeaidd a grybwyllir uchod yn cael eu trawsosod yn Rheoliadau hyn. Directive 89/397/EEC on the official control of foodstuffs (OJ No. L186, 30.6.89, p.23), a defence in relation to exports (regulations 7 and 8);

- (g) apply various provisions of the Food Safety Act 1990 (regulation 9);
- (h) revoke the previous Regulations and make consequential amendments and transitional provision (regulations 10 and 11). An effect of the revocation made by regulation 10(1) (a), and the absence of the re-enactment of a similar provision, is that Part II of the Food Labelling Regulations 1996 will apply to the products to which these Regulations apply.

A Regulatory appraisal has been prepared pursuant to section 65 of the Government of Wales Act 1998 and placed in the Library of the National Assembly for Wales together with a Transposition Note setting out how the main elements of the European legislation referred to above are transposed in these Regulations. The National Assembly for Wales, in exercise of the powers conferred by sections 16(1)(e), 17(1), 26(1) and (3) and 48(1) of the Food Safety Act 1990(a) and now vested in it(b), having had regard in accordance with section 48(4A) of that Act to relevant advice given by the Food Standards Agency and after consultation both as required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council(c) laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety and in accordance with section 48(4) and (4B) of the said Act, hereby makes the following Regulations:

1. Enw'r Rheoliadau hyn yw Rheoliadau Llaeth Cyddwys a Llaeth Sych (Cymru) 2003, deuant i rym ar 28 Tachwedd 2003 ac maent yn gymwys i Gymru yn unig.

Title, commencement and application

1. These Regulations may be cited as the Condensed Milk and Dried Milk (Wales) Regulations 2003, shall come into force on 28th November 2003 and shall apply to Wales only.

ystyr "Gwladwriaeth AEE" ("*EEA State*") yw Gwladwriaeth sy'n Barti Contractiol i Gytundeb AEE;

consumer and is ready for consumption without further preparation;

"designated product" ("*cynnyrch dynodedig*") means any food specified in column 2 of Schedule 1 (as read with the Notes relating to that Schedule);

"Directive 79/1067/EEC" ("*Cyfarwyddeb 79/1067/EEC*") means First Commission Directive 1979/1067/EEC(a) laying down Community methods of analysis for testing certain partly or wholly dehydrated preserved milk for human consumption;

"Directive 87/524/EEC" ("*Cyfarwyddeb 87/524/EEC*") means First Commission Directive 1987/524/EEC(b) laying down Community methods of sampling for chemical analysis for the monitoring of preserved milk products;

"EEA Agreement" ("*Cytundeb AEE*") means the Agreement on the European Economic Area(c) signed at Oporto on 2nd May 1992 as adjusted by the Protocol(d) signed at Brussels on 17th March 1993;

"EEA State" ("*Gwladwriaeth AEE*") means a State which is a Contracting Party to the EEA Agreement;

"food authority" ("*awdurdod bwyd*") has the same meaning as in section 5(1A) and (3)(a) and (b) of the Food Safety Act 1990;

"the 1996 Regulations" ("*Rheoliadau 1996*") means the Food Labelling Regulations 1996(e);

"partly dehydrated milk" ("*llaeth wedi'i ddadhydradu'n rhannol*") means the liquid product, whether or not sweetened, obtained directly by the partial removal of water from milk, from wholly or partly skimmed milk or from a mixture of these products and includes such a product to which cream or totally dehydrated milk have been added provided the addition of totally dehydrated milk does not exceed, in the finished product, 25% of total milk solids;

"preparation" ("*paratoi*") includes manufacture and any form of processing or treatment and "prepared" shall be construed accordingly;

ystyr "llaeth wedi'i ddadhydradu'n rhannol" ("*partly dehydrated milk*") yw'r cynnyrch hylif, boed wedi'i felysu ai peidio, a geir yn uniongyrchol drwy dynnu peth dwr o laeth, llaeth llwyr sgim neu laeth rhannol sgim, neu o gymysgwch o'r cynhyrchion hyn, ac mae'n cynnwys cynhyrchion yr ychwanegwyd hufen neu laeth sydd wedi'i ddadhydradu'n llwyr atynt ar yr amod nad yw'r llaeth wedi'i ddadhydradu'n llwyr yn fwy, yn y cynnyrch gorffenedig, na 25% o gyfanswm y solidau llaeth;

Ystod y Rheoliadau

3. Mae'r Rheoliadau hyn yn gymwys i gynhyrchion dynodedig a fwriedir i'w bwyta gan bobl ac sy'n barod i'w dosbarthu i'r defnyddiwr olaf neu i sefydliad arlwyo.

Disgrifiadau neilltuedig

4. Ni chaiff unrhyw berson werthu unrhyw fwyd ac arno label, p'un a yw wedi'i gysylltu â'r deunydd lapio neu'r cynhwysydd, neu wedi'i argraffu arno, sy'n dwyn, yn ffurfio neu'n cynnwys unrhyw ddisgrifiad neilltuedig neu unrhyw darddair ohono neu unrhyw air neu ddisgrifiad sy'n sylweddol debyg iddo oni bai -

- (a) bod y bwyd hwnnw yn gynnrych dynodedig y mae'r disgrifiad neilltuedig yn ymwneud ag ef;
- (b) bod y disgrifiad, y tarddair neu'r gair hwnnw'n cael ei ddefnyddio mewn cyd-destun sy'n dangos neu'n awgrymu yn glir nad yw'r sylwedd y mae'n ymwneud ag ef ond yn gynhwysyn yn y bwyd hwnnw; neu
- (c) bod y disgrifiad, y tarddair neu'r gair hwnnw'n cael ei ddefnyddio mewn cyd-destun sy'n dangos neu'n awgrymu'n glir nad yw'r bwyd yn gynnrych dynodedig ac nad yw'n cynnwys cynnyrch dynodedig.

relation to that product in column 1 of Schedule 1 or any alternative description permitted by Schedule 2;

"sell" ("*gwerthu*") includes offer or expose for sale or have in possession for sale, and cognate expressions shall be construed accordingly;

"totally dehydrated milk" ("*llaeth wedi'i ddadhydradu'n llwyr*") means the solid product, where the water content does not exceed 5% by weight of the finished product, obtained directly by the removal of water from milk, from wholly or partly skimmed milk, from cream or from a mixture of these products;

"total milk solids" ("*cyfanswm y solidau llaeth*") means all the constituents of milk other than water, including milk fat, the constituents other than milk fat being present in their natural proportions; and

"ultimate consumer" ("*defnyddiwr olaf*") means any person who buys otherwise than -

- (a) for the purpose of resale,
- (b) for the purposes of a catering establishment, or
- (c) for the purposes of a manufacturing business.

Scope of Regulations

3. These Regulations apply to designated products, intended for human consumption and ready for delivery to the ultimate consumer or to a catering establishment.

Reserved descriptions

4. No person shall sell any food with a label, whether or not attached to or printed on the wrapper or container, which bears, comprises or includes any reserved description or any derivative thereof or any word or description substantially similar thereto unless -

- (a) such food is the designated product to which the reserved description relates;
- (b) such description, derivative or word is used in such a context as to indicate explicitly or by clear implication that the substance to which it relates is only an ingredient of that food; or
- (c) such description, derivative or word is used in such a context as to indicate explicitly or by clear implication that such food is not and does not contain a designated product.

Labelu a disgrifio cynhyrchion dynodedig

5. Heb leihau effaith gyffredinol Rhan II o Reoliadau 1996, ni chaiff unrhyw berson werthu unrhyw gynnyrch dynodedig oni bai iddo gael ei farcio a'i labelu â'r manylion canlynol -

- (a) disgrifiad neilltuedig y cynnyrch;
- (b) ac eithrio yn achos y cynhyrchion a bennir ym mharagraffau 1(ch) ac (e) a 2(ch) o Atodlen 1, canran y braster llaeth, wedi'i mynegi yn ôl y pwysau mewn perthynas â'r cynnyrch gorffenedig;
- (c) ac eithrio yn achos y cynhyrchion a bennir ym mharagraff 2(a) i (ch) o Atodlen 1, canran yr echdyniad llaeth sych nad yw'n cynnwys unrhyw fraster o gwbl;
- (ch) yn achos cynhyrchion a bennir ym mharagraff 2(a) i (ch) o Atodlen 1, argymhellion ynghylch y dull gwanhau neu ailgyfansoddi'r cynnyrch a manylion am ei gynnwys braster pan gaiff ei wanhau neu ei ailgyfansoddi;
- (d) yn achos y cynhyrchion a bennir ym mharagraff 2(a) i (ch) o Atodlen 1, nad yw'r cynnyrch "wedi'i fwriadu yn fwyd i fabanod o dan ddeuddeng mis oed".

Dull marcio neu labelu

6.-(1) Mae rheoliadau 35, 36(1) a (5) a 38 o Reoliadau 1996 (sy'n ymwneud â'r dull o farcio neu labelu bwyd) yn gymwys i'r manylion y mae'n ofynnol marcio neu labelu cynnyrch dynodedig â hwy oherwydd rheoliad 5 o'r Rheoliadau hyn fel petaent yn fanylion y mae'n ofynnol marcio neu labelu bwyd â hwy oherwydd Rheoliadau 1996.

(2) Rhaid i'r manylion y mae'n ofynnol iddynt ymddangos ar y label yn rhinwedd rheoliad 5(b) ac (c) o'r Rheoliadau hyn ymddangos wrth enw'r cynnyrch.

(3) Pan gaiff cynhyrchion dynodedig sy'n pwysu llai na 20 gram yr uned eu pacio mewn deunydd pacio allanol, nid oes rhaid i'r manylion sy'n ofynnol gan reoliad 5(b) i (d) o'r Rheoliadau hyn ymddangos ond ar y deunydd pacio allanol.

Cosbi a gorfodi

7.-(1) Bydd person sy'n mynd yn groes neu yn methu cydymffurfio â rheoliad 4 neu 5 o'r Rheoliadau hyn yn euog o dramgwydd ac yn agored ar gollfarn ddiannod i ddirwy heb fod yn fwy na lefel 5 ar y raddfa safonol.

(2) Rhaid i bob awdurdod bwyd orfodi a gweithredu'r Rheoliadau hyn o fewn ei ardal.

Labelling and description of designated products

5. Without prejudice to the generality of Part II of the 1996 Regulations, no person shall sell any designated product unless it is marked or labelled with the following particulars -

- (a) the reserved description of the product;
- (b) except in the case of the products specified in paragraphs 1(d) and (g) and 2(d) of Schedule 1, the percentage of milk fat, expressed by weight in relation to the finished product;
- (c) except in the case of the products specified in paragraph 2(a) to (d) of Schedule 1, the percentage of fat-free dried milk extract;
- (d) in the case of the products specified in paragraph 2(a) to (d) of Schedule 1, the recommendations as to the method of dilution or reconstitution and the details of the fat content of the product when diluted or reconstituted;
- (e) in the case of the products specified in paragraph 2(a) to (d) of Schedule 1, that the product is "not intended as a food for infants under 12 months".

Manner of marking or labelling

6.-(1) Regulations 35, 36(1) and (5) and 38 of the 1996 Regulations (which relate to the manner of marking or labelling of food) shall apply to the particulars with which a designated product is required to be marked or labelled by regulation 5 of these Regulations as if they were particulars with which food is required to be marked or labelled by the 1996 Regulations.

(2) The particulars which are required to appear on the label by virtue of regulation 5(b) and (c) of these Regulations shall appear near the name of the product.

(3) Where designated products weighing less than 20 grams per unit are packed in an outer packaging, the particulars required by regulation 5(b) to (e) of these Regulations need appear on the outer packaging only.

Penalties and enforcement

7.-(1) If any person contravenes or fails to comply with regulation 4 or 5 of these Regulations that person shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale.

(2) Each food authority shall enforce and execute these Regulations in its area.

Amddiffyniad mewn perthynas ag allforion

8. Mewn unrhyw achosion am dramgwydd o dan y Rheoliadau hyn bydd yn amddiffyniad i unrhyw berson a gyhuddir i brofi -

- (a) y bwriadwyd y bwyd, yr honnir i'r drosedd gael ei chyflawni mewn perthynas ag ef, ar gyfer ei allforio i wlad sydd â deddfwriaeth gydweiddol â'r Rheoliadau hyn a bod y bwyd yn cydymffurfio â'r deddfwriaeth honno; ac

- (i) section 35(1) (punishment of offences) insofar as it relates to offences under section 33(1) as applied by sub-paragraph (g) above;
- (j) section 35(2) and (3) insofar as it relates to offences under section 33(2) as applied by sub-paragraph (h) above;
- (k) section 36 (offences by bodies corporate); and
- (l) section 44 (protection of officers acting in good faith).

3. The term "semi-skimmed milk powder" or "dried semi-skimmed milk" may be used instead of the term "dried partly skimmed milk" or "partly skimmed-milk powder" in the case of totally dehydrated milk with a fat content of between 14% and 16%.
