1. Mae'r Rheoliadau hyn, sy'n gymwys i Gymru yn unig, yn diwygio ymhellach Rheoliadau Porthiant (Cymru) 2001 (O.S. 2001/343 (Cy. 15), fel y'u diwygiwyd eisoes).

1. These Regulations, which apply to Wales only, further amend the Feeding Stuffs (Wales) Regulations 2001 (S.I. 2001/343 (W. 15), as already amended).

2. Mae'r Rheoliadau hyn yn gweithredu Cyfarwyddeb y Comisiwn 2003/7/EC sy'n diwygio'r amodau ar gyfer awdurdodi canthacsanthin mewn porthiant yn unol â Chyfarwyddeb y Cyngor 70/524/EEC (OJ Rhif L22, 25.1.2003, t. 28).

2. These Regulations implement Commission Directive 2003/7/EC amending the conditions for authorisation of canthaxanthin in feedingstuffs in accordance with Council Directive 70/524/EEC (OJ No. L22, 25.1.2003, p. 28).

3. Mae'r Rheoliadau hyn yn addasu'r dulliau rheoli yn Rheoliadau Porthiant (Cymru) 2001 sy'n rheoleiddio presenoldeb ychwanegion mewn porthiant drwy bennu lefelau uchaf newydd mewn bwyd ar gyfer y lliwydd canthacsanthin (*rheoliad 2(2) a'r Atodlen*).

3. These Regulations modify the controls in the Feeding Stuffs (Wales) Regulations 2001 regulating the presence of additives in feedingstuffs by specifying new maximum levels in feed for the colourant canthaxanthin (*regulation 2(2) and the Schedule*).

4. They also provide for the enforcement of Commission Regulation (EC) No.871/2003 permanently authorising a new additive manganomanganic oxide in feedingstuffs (OJ No. L125, 21.5.2003, p.3) and Commission Regulation (EC) No. 877/2003 provisionally authorising the use of the acidity regulator "Benzoic acid" in feedingstuffs (OJ No. L126, 22.5.2003, p.24) (*regulation 2(3)*).

Title, application and commencement

1.-(1) These Regulations may be cited as the Feeding Stuffs, the Feeding Stuffs (Sampling and Analysis) and the Feeding Stuffs (Enforcement) (Amendment) (Wales) (No. 2) Regulations 2003.

(2) These Regulations shall apply to Wales only and shall come into force on 3rd December 2003.

Amendment of the Feeding Stuffs (Wales) Regulations 2001

2.-(1) The Feeding Stuffs (Wales) Regulations 2001(a) shall be amended in accordance with paragraphs (2) and (3).

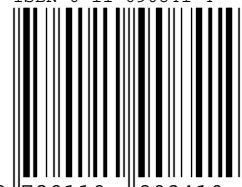
