O dan Ran II o Atodlen 8 i Ddeddf Cyllid Llywodraeth Leol 1988 mae'n ofynnol i awdurdodau bilio yng Nghymru dalu symiau (a elwir yn gyfraniadau ardrethu annomestig) i Gynulliad Cenedlaethol Cymru. Mae'r rheolau ar gyfer cyfrifo'r symiau hynny wedi'u cynnwys yn Rheoliadau Cyfraniadau Ardrethu Annomestig (Cymru) 1992 ("Rheoliadau 1992").

Mae'r Rheoliadau hyn yn diwygio Rheoliadau 1992 drwy roi illuosydd newydd ym mharagraff 2(12) o Atodlen 2 (Rhagdybiaethau ynglyn â'r Swm Gros), ac Atodlen 4 newydd (Ffigurau Poblogaeth Oedolion).

The Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 2003

EXPLANATORY NOTE

(This note is not part of the Regulations)

Under Part II of Schedule 8 to the Local Government Finance Act 1988, billing authorities in Wales are required to pay amounts (called non-domestic rating contributions) to the National Assembly for Wales. Rules for the calculation of those amounts are contained in the Non-Domestic Rating Contributions (Wales) Regulations 1992 ("the 1992 Regulations").

These Regulations amend the 1992 Regulations by substituting a new multiplier in paragraph 2(12) of Schedule 2 (Assumptions as to gross amount) and a new Schedule 4 (Adult Population Figures).

2. O ran y blynnyddoedd ariannol sy'n dechrau ar neu ar ôl 1 Ebrill 2004, diwygir Atodlenni 2 a 4 i Reoliadau 1992 fel a ganlyn:-

- (a) ym mharagraff 2(12) o Atodlen 2 yn lle "0.999" rhoddir "0.998"; a
- (b) yn lle Atodlen 4 i Reoliadau 1992 rhoddir yr Atodlen a nodir yn yr Atodlen i'r Rheoliadau hyn.

The National Assembly for Wales makes the following Regulations in exercise of the powers given to the Secretary of State by sections 140(4) and 143(1) and (2) of, and paragraphs 4 and 6 of Schedule 8 to, the Local Government Finance Act 1988(a) which are now vested in the National Assembly for Wales so far as exercisable in Wales(b):

Citation, commencement and application

1.-(1) These Regulations may be cited as the Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 2003 and shall come into force on 31st December 2003.

(2) In these Regulations "the 1992 Regulations" means the Non-Domestic Rating Contributions (Wales) Regulations 1992(c).

Amendment of the 1992 Regulations

2. In relation to financial years beginning on or after 1st April 2004, Schedules 2 and 4 to the 1992 Regulations are amended as follows:-

- (a) in paragraph 2(12) of Schedule 2 for "0.999" there is substituted "0.998"; and
- (b) for Schedule 4 to the 1992 Regulations there is substituted the Schedule set out in the Schedule to these Regulations.


