Mae'r Rheoliadau hyn yn manylu ar sut y mae adroddiad arolygu i'w gyhoeddi pan fydd ei gyhoeddi yn ofynnol gan yr awdurdod cofrestru wedi i ysgol annibynnol gael ei harolygu gan y Prif Arolygydd neu gan un arolygydd cofrestredig neu fwy o dan adran 163(1)(a) o Ddeddf Addysg 2002.

These Regulations set out the manner in which a report of an inspection of an independent school by the Chief Inspector or one or more registered inspectors under section 163(1)(a) of the Education Act 2002 is to be published when publication is required by the registration authority.

Drwy arfer y pwerau a roddwyd i Gynulliad Cenedlaethol Cymru gan adrannau 163(3)(b) a 210(7) o Ddeddf Addysg 2002(a), mae Cynulliad Cenedlaethol Cymru drwy hyn yn gwneud y Rheoliadau canlynol:

In exercise of the powers conferred on the National Assembly for Wales by sections 163(3)(b) and 210(7) of the Education Act 2002(a), the National Assembly for Wales makes the following Regulations:

**Enwi, cychwyn a chymhwyso****Name, commencement and application**

1. Enw'r Rheoliadau hyn yw Rheoliadau Ysgolion Annibynnol (Cyhoeddi Adroddiadau Arolygu) (Cymru) 2003 a deuant i rym ar 1 Ionawr 2004.

1. These Regulations are called the Independent Schools (Publication of Inspection Reports) (Wales) Regulations 2003 and come into force on 1st January 2004.

2. Mae'r Rheoliadau yma yn gymwys i Gymru.

2. These Regulations apply to Wales.

3. Nid yw'r Rheoliadau hyn yn gymwys i unrhyw arolygiad cyn 1 Ionawr 2006 o ysgol a oedd ar 31 Rhagfyr 2003 wedi'i chofrestru dros dro yn unol ag adran 465(3) o Ddeddf Addysg 1996(b).

3. These Regulations are not to apply to any inspection before 1st January 2006 of a school which was on 31st December 2003 provisionally registered in accordance with section 465(3) of the Education Act 1996(b).

4. Pan fydd yr awdurdod cofrestru yn ei gwneud yn ofynnol bod yr adroddiad arolygu a wnaed o dan adran 163(3)(a) o Ddeddf Addysg 2002 cael ei gyhoeddi, rhaid i'r person a gynhaliodd yr arolygiad -

4. Where the registration authority requires publication of a report made under section 163(3)(a) of the Education Act 2002 the person who conducted the inspection must -

- (a) anfon copi o'r adroddiad arolygu, ac unrhyw grynodedb o'r adroddiad hwnnw at y perchennog, a
- (b) rhoi copi o'r adroddiad arolygu, ac unrhyw grynodedb o'r adroddiad hwnnw, ar y rhyngwrwyd ar ei wefan.

- (a) send a copy of the inspection report and any summary of that report to the proprietor; and
- (b) place a copy of the inspection report and any summary of that report on their internet web site.

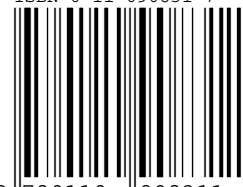
