Mae'r Rheoliadau hyn yn diwygio Rheoliadau Porthiant 2000 (O.S. 2000/2481, fel y'u diwygiwyd eisoes) i'r graddau y maent yn gymwys i Gymru, Rheoliadau Porthiant (Gorfodi) 1999 (O.S. 1999/2325, fel y'u diwygiwyd eisoes) i'r graddau y maent yn gymwys i Gymru, a Rheoliadau Porthiant (Sefydliadau a Chanolwyr) 1999 (S.I. 1999/1872, fel y'u diwygiwyd eisoes) i'r graddau y maent yn gymwys i Gymru.

1. These Regulations amend the Feeding Stuffs Regulations 2000 (S.I. 2000/2481, as already amended) which in so far as they relate to Wales, the Feeding Stuffs (Enforcement) Regulations 1999 (S.I. 1999/2325, as already amended) in so far as they relate to Wales, and the Feeding Stuffs (Establishments and Intermediaries) Regulations 1999 (S.I. 1999/1872, as already amended) in so far as they relate to Wales.

 - (iii) gosod rhwymedigaeth ar y sawl sy'n gyfrifol am sefydliadau sy'n cynhyrchu cynhyrchion ar gyfer maeth anifeiliaid i hysbysu'r Asiantaeth Safonau Bwyd a'r awdurdod lleol perthnasol a rhoi iddynt wybodaeth benodedig, os oes ganddynt dystiolaeth bod porthiant y maent wedi ei fewnforio neu beri ei gylchredeg yn cynnwys sylweddau annymunol penodol ar lefelau sy'n uwch na'r uchafswm a ragnodir (*rheoliad 5*), a
 - (iv) ychwanegu tri rheoliad newydd y Comisiwn i'r rhestr o Reoliadau'r Comisiwn yr awdurdodwyd marchnata ychwanegion porthiant odani ac a gynhwysir yn Rhan IX o'r Tabl i Atodlen 3, ac sy'n gwneud diwygiad canlyniadol i'r troednodyn i Ran VII o'r Tabl hwnnw (*rheoliad 6 a'r Atodlen*); a

4. These Regulations -

- (a) amend the Feeding Stuffs (Wales) Regulations 2001 by -
 - (i) inserting into regulation 2 a definition of the term "the Enforcement Directive" (*regulation 3*),
 - (ii) making consequential amendments to regulations 7(1) and 24(1) (*regulation 4*),
 - (iii) imposing on those responsible for establishments producing products for animal nutrition an obligation to notify the Food Standards Agency and the relevant local authority, and supply them with specified information, if they have evidence that feed materials which they have imported or put into circulation contain certain undesirable substances at levels above the maximum ones prescribed (*regulation 5*), and
 - (iv) adding three new Commission Regulations to the list of Commission Regulations under which authorisation for the marketing of feed additives has been granted, which is contained in Part IX of the Table to Schedule 3, and making a consequential amendment to the footnote to Part VII of that Table (*regulation 6 and the Schedule*); and
- (b) amend the Feeding Stuffs (Enforcement) Regulations 1999 by making consequential amendments to specified provisions (*regulation 7*), and
- (c) make consequential amendments to the Feeding Stuffs (Establishments and Intermediaries) Regulations 1999 (*regulation 8*).

5. In regulation 12 (control of feeding stuffs and feed materials containing undesirable substances), for paragraph (9) there shall be substituted the following paragraph -

"(9) Where a person to whom the first paragraph of Article 16a of the Enforcement Directive applies has evidence that any feed material specified in column 2 of Chapter A of Part II of Schedule 7, which he has brought into Wales from a third country or put into circulation and which he holds or owns, contains any substance specified in column 1 of that Chapter in excess of the level specified in relation to it in column 3 of that Chapter, he shall -

- (a) notify the Food Standards Agency and the authority which, by virtue of section 67(1A), has the duty to enforce Part IV of the Act in relation to the feed material concerned; and
- (b) supply them with the information specified in the second paragraph of Article 16a of the Enforcement Directive."

6. In Schedule 3 (permitted additives and provisions relating to their use) -

- (a) for the footnote to Part VII of the Table (permitted preservatives) there shall be substituted the following footnote -

"(1) Note also that (as referred to in Part IX of this Table) one preservative is permitted by virtue of Commission Regulation (EC) No. 1594/1999(e) and one by Commission Regulation (EC) No. 1252/2002(f)."; and

- (b) for the provisions in Part IX of the Table (European Community Regulations by which additives are controlled) there shall be substituted the provisions set out in the Schedule to these Regulations.

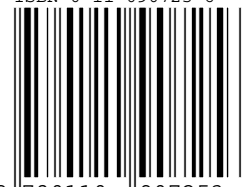
