1. Mae'r Rheoliadau hyn, sy'n gymwys i Gymru yn unig, yn diwygio Rheoliadau Ychwanegion Bwyd Amrywiol 1995, fel y'u diwygiwyd eisoes ("y prif Reoliadau") sy'n gymwys i Brydain Fawr gyfan.

2. Mae'r Rheoliadau hyn yn rhoi ar waith Cyfarwyddeb Senedd Ewrop a'r Cyngor 2003/52/EC(a) yn diwygio Cyfarwyddeb 95/2/EC(b) o ran amodau defnydd ychwanegyn bwyd E425 Konjac.

3. Mae'r Rheoliadau hyn yn darparu i E425 Konjac gael ei ddefnyddio mewn Bwydydd yn gyffredinol (ac eithrio mewn rhai bwydydd a bennir yn y prif Reoliadau) ond nid mewn cyffaith jeli. Mae cyffaith jeli yn cynnwys teisennau cwpan jeli.

4. Nid oes asesiad o effaith y rheoliadau wedi'i baratoi mewn perthynas â'r Rheoliadau hyn gan na fydd gan yr offeryn effaith ar gostau busnes. Mae nodyn trosi sy'n nodi sut y mae prif elfennau Cyfarwyddeb 2003/52 yn cael eu trosi yn y rheoliadau hyn wedi'i baratoi a'i osod yn Llyfrgell Cynulliad Cenedlaethol Cymru. The Miscellaneous Food Additives
(Amendment) (Wales) Regulations
2004

EXPLANATORY NOTE

(This note is not part of the Regulations)

1. These Regulations, which apply to Wales only, amend the Miscellaneous Food Additives Regulations 1995, as already amended ("the principal Regulations") which apply to the whole of Great Britain.

2. These Regulations implement European Parliament and Council Directive 2003/52/EC(a) amending Directive 95/2/EC(b) as regards the conditions of use for a food additive E425 Konjac.

3. These Regulations provide for E425 Konjac to be used in Foodstuffs in general (except in certain foods as are specified in the principal Regulations) but not in jelly confectionery. Jelly confectionery includes jelly mini-cups.

4. A regulatory impact assessment has not been prepared in respect of these Regulations as the instrument will have no effect on the costs of business. A transposition note setting out how the main elements of Directive 2003/52 are transposed in these regulations has been prepared and placed in the library of the National Assembly for Wales. The Miscellaneous Food Additives (Amendment) (Wales) Regulations 2004

*Made**2nd March 2004**Coming into force**5th March 2004*

The National Assembly for Wales in exercise of the powers conferred by sections 16(1)(a), 17(1), 26(1) and (3) and 48(1) of, and paragraph 1 of Schedule 1 to, the Food Safety Act 1990(**a**) and now vested in the Assembly(**b**) and having had regard in accordance with section 48(4A) of that Act, to relevant advice given by the Food Standards Agency and after consultation as required by article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(**c**) and in accordance with section 48(4) and (4B) of that Act, makes the following Regulations:

Title, commencement and application

1. These Regulations may be cited as the Miscellaneous Food Additives (Amendment) (Wales) Regulations 2004, shall apply to Wales only and shall come into force on 5th March 2004.

Amendment of the Miscellaneous Food Additives Regulations 1995

2. In Schedule 3 to the Miscellaneous Food Additives Regulations 1995(**d**), in the entry for E425 for the words in the third column of that entry, there shall be substituted the words "Foods in general (except those referred to in Schedules 6, 7 and 8, and jelly confectionery, including jelly mini-cups)".


