Bydd y weithdrefn yn gweithredu drwy gyfrwng apêl yn erbyn y penderfyniad cychwynnol a wnaed ynglŷn â'r apelydd mewn perthynas â gweinyddu unrhyw un o'r Cynlluniau a restrir yn yr Atodlen i'r Rheoliadau hyn (rheoliad 4). Gall y weithdrefn fod ar ffurf ystyriaeth gan bersonau a benodir gan y Cynulliad Cenedlaethol i gyflwyno argymhelliaid ynglyn â sut y dylid penderfynu ar y mater.

Mae'r Rheoliadau yn rhoi pŵer i dalu cydnabyddiaeth a lwfansau i unrhyw bersonau o'r fath a benodir, ac i godi ffi ar gyfer costau'r weithdrefn.

### EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations enable the National Assembly for Wales ("the National Assembly") to establish a procedure for the further consideration of an initial determination made under any of the Common Agricultural Policy ("CAP") support schemes listed in the Schedule to the Regulations. An appeal system for CAP support schemes administered under the Integrated Administration and Control System ("IACS") has already been established by the National Assembly under the Agricultural Subsidies (Appeals) (Wales) Regulations 2001 (S.I. 2001 No. 2537 (W.212)).

The procedure will operate by way of appeal from the initial determination made in relation to the appellant in respect of the administration of any of the Schemes listed in the Schedule to these Regulations (regulation 4). The procedure may take the form of consideration by persons appointed by the National Assembly with a view to their making a recommendation to it as to how the matter should be determined.

The Regulations confer power to pay remuneration and allowances to any such persons appointed, and to charge a fee in respect of the costs of the procedure.

The National Assembly for Wales being designated(a) for the purposes of section 2(2) of the European Communities Act 1972(b) in relation to the common agricultural policy of the European Community, in exercise of the powers conferred upon it by that section, hereby makes the following Regulations -

#### Title and commencement

1. These Regulations may be cited as the Common Agricultural Policy Non-IACS Support Schemes (Appeals) (Wales) Regulations 2004 and shall come into force on 1st April 2004.

#### Interpretation

2. In these Regulations -

"appellant" ("apelydd") means a person in respect of whom an initial determination has been made by or on behalf of the National Assembly in connection with the administration of any of the Schemes listed in the Schedule to these Regulations and who wishes to have that initial determination reconsidered by or on behalf of the National Assembly;

"relevant date" ("dyddiad perthnasol") means the date on which the initial determination was made; and

"the National Assembly" ("y Cynulliad Cenedlaethol") means the National Assembly for Wales.

## Cymhwysô

3. Mae'r Rheoliadau hyn yn gymwys yngylch apelwyr yr oedd eu cyfeiriad masnachu, neu os oes mwy nag un cyfeiriad o'r fath, yr oedd eu prif gyfeiriad masnachu, yng Nghymru ar y dyddiad perthnasol.

## Darparu gweithdrefn apelau

4.-(1) Caiff y Cynulliad Cenedlaethol sefydlu gweithdrefn, sydd i'w defnyddio ar gais unrhyw apelydd, ar gyfer ystyried ymhellach ar ran y Cynulliad Cenedlaethol benderfyniad cychwynnol a wnaed ynglŷn â'r apelydd mewn perthynas â gweinyddu unrhyw un o'r Cynlluniau a restrir yn yr Atodlen, a bod y weithdrefn honno yn gweithredu drwy gyfrwng apêl yn erbyn y penderfyniad cychwynnol.

(2) Caiff unrhyw weithdrefn a sefydlir felly ddarparu bod ystyriaeth o'r penderfyniad cychwynnol gan y personau (heb fod yn fwy na thri) sy'n cael eu penodi gan y Cynulliad Cenedlaethol at y diben hwnnw, a hynny gyda'r bwriad y byddent yn llunio adroddiad am eu casgliadau ynglŷn â'r penderfyniad cychwynnol ac argymhelliad ynglŷn â'r ffordd y dylai'r mater gael ei benderfynu'n derfynol ganddo

(3) Os bydd y Cynulliad Cenedlaethol yn sefydlu'r weithdrefn a grybwyllir ym mharagraff (2), caiff -

- (a) talu i'r personau a benodir felly unrhyw dâl rhesymol am eu swyddogaethau o dan y weithdrefn honno, ac unrhyw lwfansau teithio a lwfansau eraill, y bydd yn penderfynu arnynt; a
- (b) codi'r ffi (a honno heb fod yn uwch na £100) y bydd y Cynulliad Cenedlaethol yn penderfynu arni ar unrhyw apelydd y mae ei apêl yn cael ei hystyried o dan y weithdrefn a sefydlwyd felly am y costau a dynnwyd gan y Cynulliad Cenedlaethol yn rhinwedd rhoi'r weithdrefn honno ar waith mewn perthynas â'r apêl o dan sylw.

## Application

3. These Regulations shall apply in relation to appellants whose trading address, or, where there is more than one such address, whose principal trading address, was in Wales at the relevant date.

## Provision of appeals procedure

4.-(1) The National Assembly may establish a procedure, to be applied at the request of any appellant, for the further consideration on its behalf of an initial determination made in relation to the appellant in respect of the administration of any of the Schemes listed in the Schedule, such procedure operating by way of appeal from the initial determination.

(2) Any such procedure so established may provide for consideration of the initial determination by such persons (not exceeding three) as the National Assembly may appoint for that purpose, with a view to their making a report of their conclusions in relation to the initial determination and a recommendation as to the manner in which the matter should be finally determined by the National Assembly.

(3) When the National Assembly establishes any such procedure as is mentioned in paragraph (2), it may -

- (a) pay to the persons so appointed such reasonable remuneration in respect of their functions under that procedure, and such travelling and other allowances, as it may determine; and
- (b) charge any appellant whose appeal is considered under the procedure so established such fee (not exceeding £100) as the National Assembly may determine in respect of the costs incurred by it by virtue of the operation of that procedure in relation to the appeal in question.
