### **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order specifies student social workers for the purposes of section 56 of the Care Standards Act 2000. Section 56 requires the Care Council for Wales to maintain a register of social workers and social care workers of any other description specified by the National Assembly for Wales by order.

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pŵer a roddwyd iddo gan adran 56(1)(b) o Ddeddf Safonau Gofal 2000(a) ac ar ôl ymghyngħori ā Chyngor Gofal Cymru(b), drwy hyn yn gwneud y Gorchymyn canlynol:

1.-(1) Enw'r gorchymyn hwn yw Gorchymyn Cyngor Gofal Cymru (Pennu Gweithwyr Cymdeithasol o dan Hyfforddiant) (Cofrestru) 2004 a daw i rym ar 1 Ebrill 2004.

(2) Yn y Gorchymyn hwn -

ystyr "y Cyngor" ("the Council") yw Cyngor Gofal Cymru;

ystyr "y Ddeddf" ("the Act") yw Ddeddf Safonau Gofal 2000;

ystyr "gweithiwr cymdeithasol o dan hyfforddiant" ("student social worker") yw person sy'n cymryd rhan mewn cwrs a gymeradwywyd gan y Cyngor o dan adran 63 o'r Ddeddf ar gyfer personau sydd am fod yn weithwyr cymdeithasol.

**Pennu gweithwyr cymdeithasol o dan hyfforddiant**

2. Pennir gweithwyr cymdeithasol o dan hyfforddiant drwy hyn at ddibenion adran 56(1)(b) o'r Ddeddf (gofyniad i'r Cyngor gadw cofrestr o weithwyr gofal cymdeithasol penodedig).

(a) 2000 p.14. Rhoddir y pŵer i'r Gweinidog priodol a ddiffinir yn adran 121(1) o'r Ddeddf fel "the Assembly" mewn perthynas â Chymru. *Gweler* adran 5(b) o'r Ddeddf am y diffiniad o "the Assembly".

(b) *Gweler* adran 56(4) o'r Ddeddf am y gofyniad i ymghyngħori.

The National Assembly for Wales, in exercise of the power conferred upon it by section 56(1)(b) of the Care Standards Act 2000(a) and having consulted the Care Council for Wales(b), hereby makes the following Order:

**Citation, commencement and interpretation**

1. -(1) This Order may be cited as the Care Council for Wales (Specification of Student Social Workers) (Registration) Order 2004 and comes into force on 1st April 2004.

(2) In this Order -

"the Act" ("y Ddeddf") means the Care Standards Act 2000;

"the Council" ("y Cyngor") means the Care Council for Wales;

"student social worker" ("gweithiwr cymdeithasol o dan hyfforddiant") means a person participating in a course approved by the Council under section 63 of the Act for persons wishing to become social workers.

**Specification of student social workers**

2. Student social workers are hereby specified for the purposes of section 56(1)(b) of the Act (requirement for the Council to maintain a register of specified social care workers).

(a) 2000 c.14. The power is conferred upon the appropriate Minister which is defined in section 121(1) of the Act as "the Assembly" in relation to Wales. *See* section 5(b) of the Act for the definition of the Assembly.

(b) *See* section 56(4) of the Act for the requirement to consult.
