EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

(This note is not part of the Regulations)

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Cyfrifon Dysgu Unigol Cymru 2003 ("Rheoliadau 2003") yn y ddwy ffordd ganlynol.

These Regulations amend the Individual Learning Accounts Wales Regulations 2003 ("the 2003 Regulations") in the following two ways.

Mewnosodir y term "partner sifil" yn Rheoliadau 2003. O ganlyniad i hynny, mae partner sifil yn gyfartal â phriod, plentyn neu lysblentyn o ran cymhwyster o dan reoliad 4 o Reoliadau 2003. Diffinnir "civil partner" yn adran 1(1) o Ddeddf Partneriaethau Sifil 2004.

The term "civil partner" is inserted into the 2003 Regulations. A civil partner as a consequence is placed on an equal footing with a spouse, child or stepchild with regards eligibility under regulation 4 of the 2003 Regulations. "civil partner" is defined in section 1(1) of the Civil Partnership Act 2004.

Diwygir rheoliad 4(5) o Reoliadau 2003 i wneud personau sy'n cael budd-daliadau neu lwfansau penodedig, neu'u dibynyddion, yn gymwys i gael Cyfrif Dysgu Unigol Cymru, ni waeth pa lefel o addysg y maent wedi'i chyrraedd. Mewnosodir Atodlen yn Rheoliadau 2003 sy'n pennu pa fudd-daliadau a lwfansau sy'n gymwys.

Regulation 4(5) of the 2003 Regulations is amended to make persons who are in receipt of specified benefits or allowances, or their dependants, eligible for Individual Learning Account Wales, regardless of their level of educational attainment. A Schedule is inserted into the 2003 Regulations specifying the eligible benefits and allowances.

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Cyfrifon Dysgu Unigol Cymru (Diwygio) 2005 a deuant i rym ar 15 Gorffennaf 2005.

1.-(1) The title of these Regulations is the Individual Learning Accounts Wales (Amendment) Regulations 2005 and they come into force on 15 July 2005.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

(2) These Regulations apply in relation to Wales.

(3) Yn y Rheoliadau hyn ystyr "Rheoliadau 2003" ("*2003 Regulations*") yw Rheoliadau Cyfrifon Dysgu Unigol Cymru 2003(2).

(3) In these Regulations "2003 Regulations" ("*Rheoliadau 2003*") means the Individual Learning Accounts Wales Regulations 2003(2).

3. Insert the words "civil partner" after the word "spouse" in regulation 4(3)(c), (d) and (e) of the 2003 Regulations.

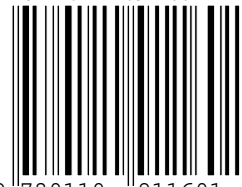
