Mae'r Gorchymyn hwn yn rhagnodi'r elfen credyd gwarant o Gredyd Pensiwn y Wladwriaeth at ddibenion adran 512ZB o Ddeddf Addysg 1996. Yr effaith yw os yw rhiant yn derbyn yr elfen credyd gwarant mae gan ei blentyn hawl i gael ciniawau ysgol am ddim.

This Order prescribes the guarantee credit element of State Pension Credit for the purposes of section 512ZB of the Education Act 1996. The effect is that where a parent is in receipt of the guarantee credit element his or her child is entitled to free school lunches.

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd gan adrannau 512ZB(4)(a)(iv) a 568 o Ddeddf Addysg 1996(1), drwy hyn yn gwneud y Gorchymyn a ganlyn:

The National Assembly for Wales, in exercise of the powers conferred by sections 512ZB(4)(a)(iv) and 568 of the Education Act 1996(1), hereby makes the following Order:

Enwi, cychwyn a chymhwyso**Title, commencement and application**

1. Enw'r Gorchymyn hwn yw Gorchymyn Addysg (Ciniawau Ysgol am Ddim) (Credyd Pensiwn y Wladwriaeth) (Cymru) 2005. Daw i rym ar 21 Tachwedd 2005 ac mae'n gynnwys o ran Cymru.

1. The title of this Order is the Education (Free School Lunches) (State Pension Credit) (Wales) Order 2005. It comes into force on 21 November 2005 and applies in relation to Wales.

Budd-dal rhagnodedig**Prescribed benefit**

2. Mae Pensiwn Credyd y Wladwriaeth sy'n daladwy o dan adran 1 o Ddeddf Credyd Pensiwn y Wladwriaeth 2002(2) yn fudd-dal a ragnodwyd at ddibenion adran 512ZB(4)(a)(vi) o Ddeddf Addysg 1996 mewn amgylchiadau lle mae'r rhiant yn derbyn yr elfen credyd gwarant o Gredyd Pensiwn y Wladwriaeth.

2. State Pension Credit payable under section 1 of the State Pension Credit Act 2002(2) is prescribed for the purposes of section 512ZB(4)(a)(iv) of the Education Act 1996 in circumstances where the parent is receiving the guarantee credit element of State Pension Credit.

Functions of the Secretary of State under sections 512ZB and 568 of the 1996 Act are exercisable by the National Assembly for Wales in relation to Wales: *see* Article 2 of, and the entry in respect of the 1996 Act in Schedule 1 to, the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672), and section 211 of the Education Act 2002 (section 201 of which inserted section 512ZB into the 1996 Act).
