EXPLANATORY NOTE

1. Mae'r Rheoliadau hyn yn diwygio Rheoliadau Labelu Bwyd (Diwygio) (Cymru) (Rhif 2) 2005 sy'n gweithredu yng Nghymru Gyfarwyddeb y Comisiwn 2005/26/EC sy'n llunio rhestr o gynhwysion neu sylweddau bwyd a eithriwyd dros dro o Atodiad IIIa o Gyfarwyddeb 2000/13/EC Senedd Ewrop a'r Cyngor (OJ Rhif L75, 22.3.2005, t.33). Yn unol â'r amserlen yn y Gyfarwyddeb honno, daw'r Rheoliadau hynny i rym ar 25 Tachwedd 2005. Mae'r Rheoliadau hynny'n rhoi esemptiad nes 25 Tachwedd 2007 o'r gofynion i labelu alergenau a geir yn rheoliad 34B o Rheoliadau Labelu Bwyd 1996 yn achos cynhwysion penodol sy'n dod o gynhwysion alergenig. Mae Rheoliadau 1996 yn rhychwantu Prydain Fawr i gyd; mae'r Rheoliadau diwygio hynny'n gymwys o ran Cymru'n unig.

1. These Regulations amend the Food Labelling (Amendment) (Wales) (No. 2) Regulations 2005 which implement in Wales Commission Directive 2005/26/EC establishing a list of food ingredients or substances provisionally excluded from Annex IIIa of Directive 2000/13/EC of the European Parliament and of the Council (OJ No.L75, 22.3.2005, p.33). In accordance with the timetable in that Directive, those Regulations come into force on 25 November 2005. Those Regulations confer an exemption until 25 November 2007 from the allergen labelling requirements in regulation 34B of the Food Labelling Regulations 1996 in the case of certain ingredients originating from allergenic ingredients. The 1996 Regulations extend to the whole of Great Britain; those amendment Regulations apply in relation to Wales only.

2. Mae'r Rheoliadau hyn yn rhoi ar waith yng Nghymru Gyfarwyddeb y Comisiwn 2005/63/EC sy'n cywiro Gyfarwyddeb 2005/26/EC (OJ Rhif L258, 4.10.2005, t.3).

2. These Regulations implement in Wales Commission Directive 2005/63/EC correcting Directive 2005/26/EC (OJ No. L258, 4.10.2005, p.3).

3. Mae'r Rheoliadau hyn-

3. These Regulations-

- (a) yn rhoi esemptiad tan 25 Tachwedd 2007 o'r gofynion i labelu alergenau a geir yn rheoliad 34B o Rheoliadau 1996 yn achos gelatin pysgod a ddefnyddir fel cariwr paratoadau carotenyn (rheoliad 4);
- (b) yn diweddarau'r diffiniad o "Directive 2000/13/EC" (rheoliad 3).

- (a) confer an exemption until 25 November 2007 from the allergen labelling requirements in regulation 34B of the 1996 Regulations in the case of fish gelatine used as a carrier for carotenoid preparations (regulation 4);
- (b) update the definition of "Directive 2000/13/EC" (regulation 3).

4. Ni luniwyd arfarniad rheoliadol manwl ar gyfer yr offeryn hwn, gan na fydd yn effeithio o gwbl ar gostau busnes.

4. A full regulatory appraisal has not been produced for this instrument as it has no impact on the costs of business.

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd gan adrannau 16(1)(e) ac (f), 17(1), 26(1) a (3) a 48(1) o Ddeddf Diogelwch Bwyd 1990(1) ac sydd bellach wedi'u breinio ynddo(2).

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred by sections 16(1)(e) and (f), 17(1), 26(1) and (3) and 48(1) of the Food Safety Act 1990(1) and now vested in it(2).

Mae wedi rhoi sylw i gyngor perthnasol a roddwyd gan yr Asiantaeth Safonau Bwyd fel sy'n ofynnol gan adran 48(4A) o'r Ddeddf honno.

It has had regard to relevant advice given by the Food Standards Agency as required by section 48(4A) of that Act.

Cafwyd ymgynghori agored a thryloyw â'r cyhoedd yn ystod cyfnod paratoi'r Rheoliadau fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor(3) sy'n pennu egwyddorion a gofynion cyffredinol cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn pennu gweithdrefnau o ran materion diogelwch bwyd.

There has been open and transparent public consultation during the preparation of the Regulations as required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council(3) laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety.

1. Enw'r Rheoliadau hyn yw Rheoliadau Labelu Bwyd (Diwygio) (Cymru) (Rhif 2) (Diwygio) 2005; deuant i rym ar 24 Tachwedd 2005.

Title and commencement

1. The title of these Regulations is the Food Labelling (Amendment) (Wales) (No. 2) (Amendment) Regulations 2005; they come into force on 24 November 2005.

2. Diwygir Rheoliadau Labelu Bwyd (Diwygio) (Cymru) (Rhif 2) 2005(1) yn unol â rheoliadau 3 a 4.

3. Yn rheoliad 3 (diwygiad o'r diffiniad o "Directive 2000/13/EC" yn rheoliad 2(1) o Rheoliadau Labelu Bwyd 1996(2)) mewnosoder ar y diwedd y geiriau "which was itself amended by Commission Directive 2005/63/EC"(3).

4. Yn yr Atodlen, yn nhestun yr Atodlen 2A newydd sydd i'w mewnosod yn Rheoliadau Labelu Bwyd 1996 (rhestr o gynhwysion sy'n dod o gynhwysion alergenig ac nad yw'r gofynion labelu alergenau yn gymwys iddynt) yng ngholofn 2 yn lle'r geiriau "Fish gelatine used as carrier for vitamins and flavours" rhodder y geiriau "Fish gelatine used as a carrier for vitamin or carotenoid preparations and flavours".

Llofnodwyd ar ran Cynulliad Cenedlaethol Cymru o dan adran 66(1) o Ddeddf Llywodraeth Cymru 1998(4).

**Amendment of the Food Labelling (Amendment)
(Wales) (No. 2) Regulations 2005**

2. The Food Labelling (Amendment) (Wales) (No. 2) Regulations 2005(1) shall be amended in accordance with regulations 3 and 4.

3. In regulation 3 (amendment of definition of "Directive 2000/13/EC" in regulation 2(1) of the Food Labelling Regulations 1996(2)) there shall be inserted at the end the words "which was itself amended by Commission Directive 2005/63/EC"(3).

4. In the Schedule, in the text of the new Schedule 2A to be inserted in the Food Labelling Regulations 1996 (list of ingredients which originate from allergenic ingredients and in respect of which the allergen labelling requirements do not apply) in column 2 for the words "Fish gelatine used as carrier for vitamins and flavours" there shall be substituted the words "Fish gelatine used as a carrier for vitamin or carotenoid preparations and flavours".
