Mae'r Gorchymyn hwn yn diwygio Gorchymyn Clefydau Anifeiliaid (Diheintyddion a Gymeradwywyd) 1978 ("Gorchymyn 1978"), O.S. 1978/32 ac yn dirymu Gorchymynion diwygio blaenorol. Mae'n disodli Atodlenni 1 a 2 i Orchymyn 1978 gan roi yn eu lle'r Atodlenni a nodir yn y Gorchymyn hwn. Mae Atodlen 1 yn rhestru diheintyddion a gymeradwywyd gan Gynulliad Cenedlaethol Cymru ac mae Atodlen 2 yn rhestru diheintyddion, er nad ydynt bellach yn gymeradwy, gellir parhau i'w defnyddio fel diheintyddion a gymeradwywyd tan 30 Mehefin 2005.

This Order amends the Diseases of Animals (Approved Disinfectants) Order 1978 ("the 1978 Order"), S.I. 1978/32 and revokes earlier amendment Orders. It substitutes for Schedules 1 and 2 to the 1978 Order the Schedules set out in this Order. Schedule 1 lists disinfectants approved by the National Assembly for Wales and Schedule 2 lists disinfectants which, although no longer approved, can continue to be used as approved disinfectants until 30 June 2005.

The National Assembly for Wales, in exercise of its powers under sections 1, 7 and 23(f) and (g) of the Animal Health Act 1981(1), which are now vested in it makes the following Order:

Title, commencement and application

1.-(1) This Order may be cited as the Diseases of Animals (Approved Disinfectants) (Amendment) (Wales) Order 2005 and comes into force on 1 April 2005.

(2) This Order applies to Wales only.

**Amendments to the Diseases of Animals
(Approved Disinfectants) Order 1978**

2.-(1) The Diseases of Animals (Approved Disinfectants) Order 1978(2) ("the 1978 Order") is amended in relation to Wales in accordance with the following provisions of this article.

(2) In paragraph (2) of article 6 of the 1978 Order (which specifies the date until which disinfectants subject to transitional provisions remain approved), for "31st August 2003" there is substituted "30 June 2005".

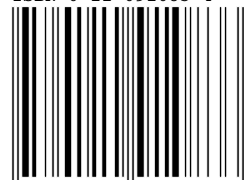
