The National Assembly for Wales, having consulted those persons which it is required, by section 4(3) of the Local Government Act 1999(1), to consult, makes the following order in exercise of the powers conferred on it by section 4(1)(a) and (2) and section 29(1) of that Act.

Name, commencement and application

1.-(1) The name of this order is the Local Government (Best Value Performance Indicators) (Wales) (Revocation) Order 2005 and it comes into force on the 1 April 2005.

(2) This order applies only in relation to Wales.

Revocation

2. The Local Government (Best Value Performance Indicators) (Wales) Order 2002(2) is revoked.
