EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau.)

(This note is not part of the Regulations)

Effaith gyffredinol darpariaethau Deddf Archwilio Cyhoeddus (Cymru) 2004 ("y Ddeddf") yw rhoi nifer o swyddogaethau newydd i Archwilydd Cyffredinol Cymru. Effaith fwyaf arwyddocaol y swyddogaethau newydd yw mai'r Archwilydd Cyffredinol, pan fydd y Ddeddf mewn grym yn llwyr, fydd yn arfer y rhan fwyaf o'r swyddogaethau a arferir ar hyn o bryd yng Nghymru gan y Comisiwn Archwilio ar gyfer Awdurdodau Lleol a'r Gwasanaeth Iechyd Gwladol yng Nghymru a Lloegr ("y Comisiwn Archwilio").

Mae'r diwygiadau a wneir gan y Rheoliadau hyn yn ganlyniad i'r newid hwnnw. Maent yn diwygio pum set o Reoliadau ym maes addysg, dwy set o ran y Gwasanaeth Iechyd Gwladol, a dwy set ym maes llywodraeth leol.

Yn y maes addysg, mae rheoliadau 3, 8, 9 a 10 yn diwygio'r gofynion, a osodir yn yr is-ddeddfwriaeth a ddiwygiwyd, ar gyfer ardystio grantiau. Ym mhob achos, mae'r diwygiadau'n darparu, o ran Cymru, y gwneir yr ardystio o hyn ymlaen gan archwilydd a benodwyd gan Archwilydd Cyffredinol Cymru (yn hytrach na chan y Comisiwn Archwilio), neu gan archwilydd cymwys ar gyfer penodiad o'r fath.

Mae'r ddarpariaeth sy'n weddill o ran y maes addysg, rheoliad 5, yn darparu bod adroddiadau o arolygiadau awdurdodau addysg lleol yng Nghymru a gyflawnir o dan adran 38 o Ddeddf Addysg 1997 (fel y'i diwygiwyd) i'w hanfon at Archwilydd Cyffredinol

The general effect of the provisions of the Public Audit (Wales) Act 2004 ("the Act") is to confer a number of new functions on the Auditor General for Wales. The most significant effect of the new functions is that the Auditor General will, from the coming into force of this Order, exercise most of the functions currently exercised in Wales by the Audit Commission for Local Authorities and the National Health Service in England and Wales ("the Audit Commission").

The amendments made by these Regulations are consequential upon that change. They amend five sets of Regulations in the education field, two sets relating to the National Health Service, and two in the local government field.

In the field of education, regulations 3, 8, 9 and 10 amend the requirements, laid down in the subordinate legislation amended, for the certification of grants. In each case, the amendments provide that, in relation to Wales, certification is henceforward to be done by an auditor appointed by the Auditor General for Wales (rather than by the Audit Commission), or an auditor qualified for such appointment.

The remaining provision concerning the education field, regulation 5, provides that reports of inspections of local education authorities in Wales carried out under section 38 of the Education Act 1997 (as amended) are to be sent to the Auditor General for

Mae rheoliadau 2 a 6 yn ymwneud â materion ynglŷn â'r Gwasanaeth Iechyd Gwladol.

Mae rheoliad 2 yn ymwneud â'r amgylchiadau pan fo'n rhaid i ymddiriedolaeth Gwasanaeth Iechyd Gwladol gynnal cyfarfod cyhoeddus. Mae'n parhau'r sefyllfa bod yn rhaid cynnal cyfarfod pan fo ymddiriedolaeth Gwasanaeth Iechyd Gwladol yn derbyn adroddiad buddiant cyhoeddus oddi wrth ei archwilydd. O ganlyniad i'r Ddeddf, gwneir yr adroddiadau hynny, o 1 Ebrill 2005 ymlaen, gan Archwilydd Cyffredinol Cymru, yn hytrach na chan y Comisiwn Archwilio. Mae'r diwygiadau a wneir gan reoliad 2 yn adlewyrchu hyn.

Mae rheoliad 6 yn darparu, pan fydd cyrff y Gwasanaeth Iechyd Gwladol ac awdurdodau lleol yng Nghymru yn ymrwymo mewn trefniadau cronfa gyfun o dan Reoliadau Trefniadau Partneriaeth Cyrff Gwasanaeth Iechyd Gwladol ac Awdurdodau Lleol (Cymru) 2000, y dylai cyfrifon y gronfa gyfun gael ei harchwilio gan Archwilydd Cyffredinol Cymru, yn hytrach na chan y Comisiwn Archwilio.

Diwygir yr is-ddeddfwriaeth ym maes llywodraeth leol gan reoliadau 4 a 7.

Mae rheoliad 4 yn diwygio'r diffiniad o "the auditor" yn Rheoliadau Awdurdodau Lleol (Contractau) 1997. Effaith y diwygiad yw, ar gyfer cyrff sy'n awdurdodau lleol at ddibenion y Rheoliadau hynny, ac sydd hefyd yn gyrrff llywodraeth leol yng Nghymru at ddibenion adran 12 o'r Ddeddf, ystyr "the auditor" yw'r archwilydd a benodir gan Archwilydd Cyffredinol Cymru o dan adran 13 o'r Ddeddf. Mae hyn yn cael effaith ar y gofynion y mae'n rhaid i awdurdodau lleol penodol eu cyflawni er mwyn i gontract y maent yn ymrwymo iddo fod yn gontract ardystio o dan Ddeddf Llywodraeth Leol (Contractau) 1997.

Mae rheoliad 7 yn ychwanegu Archwilydd Cyffredinol Cymru at y rhestr o bersonau y caniateir i swyddogion monitro awdurdod lleol ddatgelu gwybodaeth iddo at ddibenion penodol, o dan Reoliadau Ymchwiliadau Llywodraeth Leol (Swyddogaethau Swyddogion Monitro a Phwyllgorau Safonau) (Cymru) 2001.

Wales, rather than to the Audit Commission.

Regulations 2 and 6 deal with matters related to the National Health Service.

Regulation 2 concerns the circumstances in which a National Health Service trust in Wales must hold a public meeting. It maintains the position that a meeting must be held where a National Health Service trust receives a public interest report from its auditor. As a consequence of the Act, such reports will, from 1 April 2005, be made by the Auditor General for Wales, rather than the Audit Commission. The amendments made by regulation 2 reflect this.

Regulation 6 provides that, where National Health Service bodies and local authorities in Wales enter into pooled fund arrangements under the National Health Service Bodies and Local Authorities Partnership Arrangements (Wales) Regulations 2000, the accounts of the pooled fund should be audited by the Auditor General for Wales, instead of the Audit Commission.

Amendments to subordinate legislation in the field of local government are made by regulations 4 and 7.

Regulation 4 amends the definition of "the auditor" in the Local Authorities (Contracts) Regulations 1997. The effect of the amendment is that, for bodies which are local authorities for the purposes of those Regulations, and are also local government bodies in Wales for the purposes of section 12 of the Act, "the auditor" means the auditor appointed by the Auditor General for Wales under section 13 of the Act. This impacts on the requirements which certain of those local authorities must fulfil in order for a contract into which they enter to be a certified contract under the Local Government (Contracts) Act 1997.

Regulation 7 adds the Auditor General for Wales to the list of persons to whom local authority monitoring officers are allowed to disclose information for certain purposes, under the Local Government Investigations (Functions of Monitoring Officers and Standards Committees) (Wales) Regulations 2001.

Citation, commencement and application

1.-(1) These Regulations may be cited as the Public Audit (Wales) Act 2004 (Consequential Amendments) (Wales) Regulations 2005 and come into force on 1 April 2005.
